Sir,

In producing herewith arrested accused person namely Subrata Bose (57 ys) S/O Late Chityaranjan Bose of Surya Sen Colony, Block -C, PS- NJP, Dist- Jalpaiguri along with seized articles vize- i) 10 (Ten) sealed Bottles of Himalayan Gold 60 up country spirit each containing 600 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 120 each (Amounting of Rs 120/- x 10 =RS.1200/-) in which one sealed bottle has taken from mother packet box as sample and ii) 05 sealed bottles of McDowell No.1 Luxury Premium Whiskey containing 180 ml in which one sealed bottle has taken from mother packet box as sample as per seizure list.

I, ASI Subir Sen of Siliguri PS, SPC do here by lodged a written complaint against above noted arrested accused person Subrata Bose (57 ys) S/O Late Chityaranjan Bose of Surya Sen Colony, Block -C, PS- NJP, Dist- Jalpaiguri to the effect that on 04.12.21 at 14.25 hrs acting on secret information, I received a source information that the above noted person was busy to sale Id liquor illegally in his shop styled as Laxmi Dasakarma BHandar situated at Tikiapara more, Ward No.28, under Siliguri PS in order to clandestinely dispose the same. Accordingly the fact is diarized in GD vide Siliguri PS GDE no. 229 dated 04.12.21 and informed the fact to I/C Siliguri PS. As per direction of I/C Siliguri PS, I along with ASI Dhruba Misra, CV-622 Ramanath Barman left for Tikiapara more, Ward No. 28, under Siliguri PS to verify the veracity of the information vide Siliguri PS GDE no. 230 dated 04.12.21. On reaching at 14.45 hrs there and as identified by source cordoned the above noted area where he was selling illegal alcohol. On seeing the police party the above noted person tried to escape from the spot but we managed to apprehend the above noted person and on interrogation, he disclosed his identity as noted above. On being asked he stated that he used to sale the 60 up Country Spirit and foren liquor to locality without any valid documents as he has violated the norms of Bengal Excise Act for selling the said seized articles without any valid license. searching i) 10 (Ten) sealed Bottles of Himalayan Gold 60 up country spirit each containing 600 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 120 each (Amounting of Rs 120/- x 10 =RS.1200/-) in which one sealed bottle has taken from mother packet box as sample and ii) 05 (five) sealed bottles of McDowell No.1 Luxury Premium Whiskey containing 180 ml in which one sealed bottle has taken from mother packet box as sample which was kept concealed in his shop situated at Tikiapara more, Ward No. 28, under Siliguri PS. On being interrogation he could not produce any valid documents in respect of the said liquor. He also stated that he is doing this liquor business since long for wrongful gain. Accordingly I seized the same in presence of witness duly signed by them. The seizure and label was made in between 15.05 hrs to 16.40 hrs. As such I arrested her U/S-41 Cr.P.C after observing all sorts of rules.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused person namely Subrata Bose (57 ys) S/O Late Chityaranjan Bose of Surya Sen Colony, Block -C, PS- NJP, Dist- Jalpaiguri along with seized articles under proper section of law and arrange for its investigate.
