In producing here with the one accused person namely Dipankar Roy (23) s/o Dulal Chandra Roy of Nebadhai, Bidhan Pally, PS Barasat, Dist. North 24 Parganas along with following seized articles as per proper seizure list:

1. Three Bottles of SEAGRAMS ROYAL STAG DELUXE WHISKY containing 750 ml.
2. One Bottle of SEAGRAM BLENDERS PRIDE RARE PREMIUM WHISKY each bottle containing 750 ml.
3. One Bottle of Old Monk Deluxe RUM XXX each Bottle containing 750 ml.
4. One Bottle of ZONG red wine Premium containing 750 ml.

I, SI Kamal Kumar Sarkar of Bhaktinagar PS under Siliguri Police Commissionerate lodged this written complaint against the above noted accused person to the effect that on 10/12/2021 at around 22.25 Hrs while performing Special Naka Checking at Tri Junction, Check post under Bhaktinagar PS apprehend one person who disclosed his identity as noted above along with the above noted seized articles without any documents. On enquiry the apprehended person admitted his guilt and stated that he has procured the above seized liquor from Sikkim without any Documents for his wrongful gain for selling the same in his locality. Accordingly, I prepared seizure list of the above noted articles in presence of witnesses duly sign by the accused as well as witnesses. The seizure made between 22.40 hrs to 23.05 hrs. I arrested the apprehended accused person u/s 41 Cr.P.C appraising him the ground of arrest.

I, therefore pray before your kind honour that a specific case may be started against the accused person namely Dipankar Roy (23) s/o Dulal Chandra Roy of Nebadhai, Bidhan Pally, PS Barasat, Dist. North 24 Parganas under proper section of law and arrange for its investigation.
