In producing here with one accused person namely Man Mohan Mandal(24) S/O Gouranga Mandal of Ranjit More, Ps-Bhaktinagar, Dist- Jalpaiguri along with the following seized articles as per proper seizer list.

1. Twenty two (22) bottle of Himalayan Gold Country sprit 60 UP each bottle 600 ml.

I ASI Ram Prasad Adhikari of Ambari Falakata OP under NJP PS, SPC lodge a written complain against the above noted person to the effect that today 11.12.2021 at about 14.05 hrs received a source information that one Dt 11/12/21 I Man Mohan Mandal(24) S/O Gouranga Mandal of Ranjit More, Ps-Bhaktinagar, Dist- Jalpaiguri has gathered huge amount of liquor illegally for selling the same in the customer for his wrongfull gain. This refers to Ambari Falakata OP GDE no 345 informed to O/C Ambari Falakata OP about the information. As per his kind instruction I along with C/393 Subash Das and C/625 B Das proceed to Nepali Busty Farabari to work out the information. At 14:55 hrs we reached at the spot, sometime after being identified by the source our police party held raid at Nepali Busty Farabari to Man Mohan Mandal(24) S/O Gouranga Mandal of Ranjit More, Ps-Bhaktinagar, Dist- Jalpaiguri. seized the above noted articles from the possession of noted accused person which was kept under plastic bag. On demand he could not produce any valid licence/document in support of said liquor he become nervous and admitted his guilt before us and stated that that he sell the same in the customer since long for his wrongfull gain. In presence of witness namely Preetam Shekhar Das S/O Lt Gautam Das of Mahamaya colony PS NJP Dist Jalpaiguri 2) C/393 Shymal Roy of Ambari Falakata OP PS NJP Dist Jalpaiguri. I seized the above noted article from the possession of noted accused person and in presence of witness person after preparing proper seizure list and took signature of the accused person and witness. The seizure was made between 15:05 hrs to 15:35 hrs. I arrested the said person u/s 41CrPC and issued Memo of arrest appraising the ground of arrest in presence of witness.

I Therefore request you that a specific case may kindly be started against the accused person namely Man Mohan Mandal(24) S/O Gouranga Mandal of Ranjit More, Ps-Bhaktinagar, Dist- Jalpaiguri, under proper section of law.
