Sub- Prayer for lodging a FIR against the accused person

Sir,

With due respect, I PSI Asraf Alam of Mathabhanga PS/Coochbehar would like to inform you that On 04.12.2021 Dr. Sushanta Barman MO of Mathabhanga S,D Hospital gave a written requisition for conducting PM examination of one deceased namely Khadija Bibi (33yrs) W/o- Kapil Miya of Bhogramguri PS- Mathabhanga Dist- Coochbehar. Over this written Information started Mathabhanga PS UD Case No-99/21 Dt-04.12.2021 and IC PS endorsed me for its Investigation. Accordingly, myself along with UD c/676 Tapan Mitra of Mathabhanga PS/CBR went to Mathabhanga S.D hospital for surathal report During Surathal I found a black spot on the right side of the deceased neck and I also saw black spot along the spine of the back . I Interrogated the husband of the deceased and learnt that the deceased women had been suffering from stomach ailment for a long time and that she was married to her husband for 04 years back. As I send a requisition before Mathabhanga SDO Office for providing an Executive Magistrate for the preparation of her Inquest. Accordingly SDO Mathabhanga/CBR ordered Shri Phintso Sherpa WBCS(Exe). Executive magistrate, Mathabhanga to conduct Inquest over the body of the deceased. We both of us prepared Surthal/Inquest over the body.

During further Interrogation of Kapil Miya, I could learn that Kapil Miya married the deceased Khadija Bibi four(04) years ago and after marriage they lived at pachkalguri, PS- Matigara Dist- Darjeeling on a rented house. Infact Kapil Miya is a married man and had married the deceased who was already married to Bipin Barman of Patchara Gopalpur PS- Mathabhanga Dist- Coochbehar. The deceased women had been suffering from stomach ailments for a long time and used to stay with Kapil Miya at Pachkolguri. On 04.12.2021 morning when she died Kapil miya (Deceased Husband) brought her in a private ambulance to Gopalpur for burial. But the local people and their family members prevented them from her burying . Then Kapil miya took the dead body to Mathabhanga S.D Hospital and registered as brought dead accordingly police was informed. The statement of Kapil Miya is incoherent .

On 07.12.2021, I received the Post- Mortem report from Mathabhanga S.D Hospital . Where Dr. Niranjana Das ,Medical Officer Of mathabhanga S.D Hospital opined that Khadija Bibi(deceased) died due to strangulation and the manner of causation of injuries are homicidal in Nature.As per interrogation revelation of Kapil Miya along with circumstances, it is believed that Kapil Miya(38yrs) S/o- Jonnodin Miya of Bhogramguri PS- mathabhanga Dist- coochbehr. had murdered his wife Khadija Bibi and had concealed it.

Under these circumstances ,I pray before your kind honour that a specific case may be started under proper section of law against the Involved accused husband of this crime.




