I Sri Jyotirmoy Das resident of Tilak Road, Ward No.XII, of Siliguri Municipal Corporation Area, Hakimpara, P.O.&P.S. Siliguri. Dist. Darjeeling, Pin 734001 do hereby inform your good office that around 9.45 pm dated 11.12.2021 while I was walking at Bimal Sinha Sarani with my wife & daughter, suddenly Sri Kajal Kundu who is the owner of "The Original Dada Bhai Hotel" situated at Bimal Sinha Sarani, Ward No. XII of Siliguri Municipal Corporation Area, P.S.Siliguri under your geographical limits along with some 3-4 men surrounded me and wrongfully obstructed me and my wife & daughter from going further and started threatening me with death consequences amd with illicit & derogatory statements like "Anti Social, Choritrohin, Gayab Kore debo" and many such obscene remarks which outraged a woman's modesty in front of my wife and daughter. When I tried to stop him he made sexually explicit remarks with an intention of disrobing and thereafter pushed me on the streets where I was about to get hit by a vehicle running in such hasty lane with an intention to voluntarily cause hurt to me.

On being traumatized with such horrible incident my daughter took me & my wife to our house and rushed inside our room and locked us up to protect and save from him immediately.

I am thus filing this FIR before your goodself to immediately take action as per the applicable laws in India and take action against the culprits as early as possible.
