On 28th Nov 2021 Miss Payel Majumder insisted to me to take SBI credit card at 11:28 a.m., 3:35 pm and on 26th Nov 2021 also at 10:58 am over phone from no. 81166-67377. Then I went to SBI Siliguri Court Branch on 26.11.2021 and met her to submit all the documents regarding SBI credit card.

On 8.12.21 I received the card through Blue Dart Courier Service. After that 15th Dec 2021 I received one phone to activate my card from phone no. 8371872330 at 5:07 p.m. and I did not do it as I was out of home. But today, at 3:29 p.m. I received one phone from the no. 8371872330 for activation of my card. and I was asked to confirm my name, date of birth, last 4 digits of credit card and date of validity of credit card and I have confirmed all my details and even I shared OTP from my phone for activation of my card.

Henceforth and amount of Rs one lakh (1 lakh) only has been deducted / spent from my card on 16.12.21 at 3:45 p.m.

I phone to customer care and came to know the amount has been deducted but transaction is now under process.

Sir I am humbly request you to look into the matter and take necessary action Please.
