This is to inform you that, I, Santanu Sarkar, s/o Late Dilip Kumar Sarkar, residing at AJ-267 Salt Lake, Sector 2, Kolkata 700091, working as a director of Leidenschaft Lifestyle Private Limited having its registered office at A-115, First Floor, Block A, City Centre, New Town, Kolkata 700157 and its branch at A-0001, Ground Floor, Block-A City Centre, NH 31, Matigara, Siliguri 734010, under your jurisdiction.

The company is into retail trade of Watches and other lifestyle products and have opened this store at A-0001, Ground Floor, Block-A City Centre, NH 31, Matigara, Siliguri 734010 during September 2014. The store was under proprietorship at the very beginning and was taken over by our private ltd company w. e. f. 01-04-2015. As all the directors of the company are residents of Kolkata the store was always managed by employees of the company who are residents of vicinity, processing

The directors used to visit the stores one or twice in a month for three to seven days to check the proceedings and accounts and went back if all were found to be satisfactory. This continued till middle of March 2020 and after that there was Lockdown due to covid 19 Pandemic. Before the 1st Lockdown there were four employees of the company 1. Mr. Nitesh Tamang (Store Inchage), 2. Nitesh Kafley (assistant Inchagre), 3. Ms. Namita Limbu & 4. Ms. Mandeepa Sarki.

As the 1st Lockdown was withdrawn, Ms. Namita Limbu & Ms. Mandeepa Sarki did not join to work, and as the market was very poor and a little footfall happening at the City Centre, Mr. Nitesh Tamang suggested that the stores should be operated by him and Nitesh Kafley for the time being and when the market would improve the company should hire additional employee/s and the directors agreed to this proposal. It's a matter of fact that the market did not improve to the desired level therefore the company did not employ anyone.

The directors could not travel to Siliguri since the ease of 1st Lockdown as they waited for vaccination and believed Nitesh Tamang & Nitesh Kafley are doing their best for the company. The accounts of every months were taken to the registered office to submit GST & other returns.

I and another director Mrs. Suchismita Sarkar finally came to Siliguri Stores (after March 2020) on 27-11-2021 and after annexing books of accounts, stocks & reports and found the followings to our surprise:

- 1. There was shortage of cash of Rs 29,526.00 from that showing in the books of accounts.
- There was shortage of stock of 12 (twelve) watches than that showing in the stock book of accounts and the details are as per following:

The MRP value of the above 12 watches and the missing cash is estimated to Rs 7,00,000.00.

Mr. Nitesh Tamang (Aadhaar Number 2685 5593 1272, resident of upper bagdogra-734014) & Mr. Nitesh Kafley (Aadhaar Number 4379 7916 8884 resident of Kalamjote, Matigara -734012) could not answer satisfactorily but have accepted that there is some missing stocks as well as some cash.

I had closed the store on 29-11-2021 to prevent further misappropriation and gave them time to return the missing cash and watches (or money equivalent to their MRP) and went back to Kolkata.

I have realised that they have sold the watches under our GST Invoice and have later changed the Invoices in the system, that's why when we took the accounts to registered office online, could not realise the misappropriation and have submitted GST and other returns as per accounts given by them.

I have come back on 18-12-2021, but they have done nothing till now. I feel that they have cheated the company and their doings are actually act of mistrust.

I would therefore request you to register a FIR, investigate and take necessary legal action as you deem fit.
