Sir,

With due respect, I SI Ganesh Roy of NJP PS, SPC, producing herewith two accused persons namely 1) Karan Chowhan (29) s/o Narayan Chowhan of Bara- Majlishpur, PS- Goalpukur, Dist.- Uttar Dinajpur 2) Md. Rakimul (39) S/o Lt. Md. Karimuddin of Kestopur, Hallal Chowk, Pokoria, PS-Bagdogra, Dist.- Darjeeling along with following articles/Bullocks under seizure;

- 1. One Truck bearing Regd. No. WB 91 1307 loaded with 20 (Twenty) numbers of Bullocks white and red in colour.
- 2. One Truck bearing Regd. No. WB 73D 8489 loaded with 20 (Twenty) numbers of Bullocks white and red in colour.

I beg to report that on 21.12.2021 at 20.10 hrs vide NJP PS GDE No. 1502 myself along with SI Samik Paul, N-0089 Shyamal Roy, N- 0065 Prakash left for Mobile duty at PS area. During patrolling at 2015 hrs I received a secret source information that two Truck bearing Regt no. 1) WB 91 1307 and 2) WB 73D 8489 loaded with cattle are coming from Phasidewa side towards Jalpaiguri through Fulbari Toll Gate with carrying Bullocks/cattle illegally. Accordingly, I shared the information with O/C, NJP PS, SPC and as per direction we reach at Fulbari toll gate under NJP PS to verify the veracity of the information. We started keeping watch at Fulbari toll gate. Accordingly at around 20.25 hrs on 21.12.2021 the above noted vehicles arrived at Fulbari Toll Gate under NJP P.S. We tried to stop the said vehicles but driver of the above noted vehicles tried to flee away, after hot chase somehow we manage to stop the above noted vehicles at Fulbari Toll Gate and we apprehended driver of the vehicle bearing registration No. WB 91 1307 and Driver of the vehicle bearing registration no.-WB 73D 8489. On interrogation they disclosed their identity as noted above. Accordingly, I search the both vehicles and found that 40 number of bullocks loaded on the vehicle in immovable condition without reasonable cause, abandons any animals in circumstances which render it likely that it will suffer pain by reason of starvation or thirst.

On demand the apprehended persons failed to produce any valid documents with respect of the bullocks loaded on their respective vehicle and they also failed to produce any veterinary Certificate and papers of the said vehicles. Further, being interrogated, they admitted that they were carrying the bullocks illegally being procured in fraudulent means and were loaded from Phansidewa to dispose the same somewhere in Jalpaiguri and they further admitted that they were doing this illegal act since very long for their illegal gain. Subsequently, I seized the above noted vehicles being loaded with 40 nos of

Bullocks from their possessions in between 20.45 hrs to 21.30 hrs after preparing proper seizure list duly signed by them and seizure witnesses.

I arrested above noted accused persons from the spot under proper Memo of Arrest duly signed by them apprising them their ground of arrest & observing legal formalities.

From the above noted facts and circumstances, it is evident that the arrested accused person namely 1) Karan Chowhan (29) s/o Narayan Chowhan of Bara- Maileshpur, PS- Goalpukur, Dist.- Uttar Dinajpur 2) Md. Rakimul (39) S/o Lt. Md. Karimuddin of Kestopur, Hallal Chowk, Pokria, PS-Bagdogra, Dist.- Darjeeling are involved in the racket of smuggling of cattle after procuring the same in fraudulent means for their illegal gain.

Therefore, I pray before you that a specific case may kindly be started against the above noted accused persons under proper sections of law and arrange for its investigation.
