Subject: F.I.R. against False Allegation & Conspiracy of total disaster.

Sir.

I, Usha Rani Das wife of Late Upendra Chandra Das, permanent resident of Loknath Nagar, P.S-Bugdogra, Dist.- Darjeeling at the age of 63 years do hereby beg to state that, the social marriage of my son Dipankar Das was solemnized with Smt. Mahuya Sarkar (M. No. 9932210394) resident of Debalaya, Nivedita Sarani, P.O.-Kadamtala, Shiv Mandir, P.S.- Matigara, Dist.-Darjeeling for the first time on 05.03.2007. Soon after one year of her marriage, lust for property and some abnormal perverted obtrusive attitude of Mahua Sarkar and her parents continue to came to our notice. After 3/4 years later when she realize that, no more she will hide her incompetence to carry baby she tried to shelter of deception. In the year 2011 fortunately she got a teacher job at Aibheel T.G. Jr. High School", P.O- Chalsa, P.S-Matiali and as soon as started to stay at malbazar. Since then she and her mother Smt. Arati Sarar started continuous mental pressure on my son Dipankar to get separated from us & to stay with her at malbazar. But it was not possible for Dipankar to leave bugdogra by leaving his old aged ill mother & father alone. Some months later (say at the year 2012) her visit & return visit was very limited and during those days she & her mother leaving their slough now and then over telephone and sitting face to face started pressure on us for property separation. A considerable amount was also given to her. It is also to be noted that, all the marriage ornaments of both end remain always under her and her mother's custody at Shiv Mandir including her all educational and personal documents. Not only that, some important documents of my son Dipankar had also taken by her without any consent. In due time, under this mental pressure I lost my husband and my children lost their father,

Not the end here. Besides these she also tried to make turmoil in between my daughter (Mthu) and her husband during the year 2013 and let them under mental harassment too. As a result, once my daughter-in-taw stopped his communication in all respect with us. Year 2014-2015 she used to come in my house with various demands and finally physically hackled me & my son as a result my physical condition deteriorates at a fast rate.

In sepetember'2015 after a long period one day Mahuya came at our house with her mother and started the same nuisance intentionally without caring my serious illness due to COPD (asthma), CKD (Kidney Problem), High BP & high Sugar. Physically hackled me and I became very serious. When my son protests them, they mutually also attack my son and they leave by taking some remaining cloths and other important personal materials of my son.

After that as such no communication and my son Dipankar & Mahua both file a mutual divorce petition at siliguri court. One /two hearing dates were also given. But surprisingly once came again in our house and she requested me and my son not to continue the divorce case. But also verbally assuring that, if both of them got second married they will have no objection. In the year 2016 Smt. Mahuya Sarkar got 2nd marriage with Mr. Bhabotosh Baroi, resident of Ananda Nagar, Near Moynaguri Rail Station, Moynaguri (whose, 1st wife died and have two children of his 1st side), and heard that the marriage was officially registered tentatively on 9th October'2016. Naturally after that, Dipankar also got 2nd marriage mainly for the take care of his ill mother and accompany as no boly else stay in the house during his absence. In due course, two /three times Mahuya had come to our house with her mother Arati Sarkar at bagdogra to get financial help for her (Mahuay's) mental medical treatment and ever operation. A considerable amount were also given 3/4 times to Mahuya & her mother.

But surprisingly on 19.04.2018, Mahuya Sarkar deliberately come in my house at bagdogra with her mother and brother. When requested to leave my house, they forcefully entered into the house and demanded

a huge amount of Rs.1500000/- to 2000000/- and part of ownership of my other properties like house. But when I refused and repeatedly requested them to leave, started physical hackle on me & my son and also threaten kill to kill us. But on the next day found that, she had put a FIR mentioning absolutely false different issues more than II years later of her first marriage including my married daughter and daughter-in-law's name, who were not present and are completely innocent and not able to visit & stay at bugdogra hardly more than 5 to 10 days in a year. As a result, daughter-in-law and his whole family influenced under mental harassment. Finally, with this unexpected shock daughter-in-law lost his father on 18.12.2020.

On 19.11.2021 Mahuya Sarkar came in my house at about 1.00 pm with her mother and brother like as previous case and started conflict with the same demands as mentioned above. I requested them to leave as the only other resident Dipankar was not present in the house then. But they don't care my illness and request and started physical hackling and threatens to kill by burning. In due time my son came and try to restrict with me. She & her brother then start physical hackle on my son and they also threaten him to kill by burning with me. Further that, again found that, on 19.11.2021, which date is more than 14 years of her first marriage, married daughter too in her FIR. Just opposite like as facts that happen on 19.04.2018.

Under the above circumstances, it is therefore prayed that, please look into the matter with top priority and take legal action(s) against Smt. Mahuya Sarkar for such unremitting intentional false allegation & persons involved in the conspiracy such as Sri. Bhabotosh Baroi 2nd (present) Husband of Mahuya (Teacher of kalirhat Jr. Primary school. Movnaguri circle-4,), mother Smt. Arati Sarkar & brother Manas Sarkar (Nivedita Sarani, P.O.-Loriceling) & cousin brother Mr. Partha Biswas (NBU Exam. Deptt. Staff. N.B.U. Shiv Mandir) to humiliate & mental harassment with threatens to kill me and my family at your earliest to restrict the sudden disaster.
