In producing herewith arrested accused namely (i) Md Idrij Ali@ Manik (27) S/O Md Halim of Biswas Colony, Patti Mill, Near TIP office, PS Matigara, Dist: Darjeeling (ii) Rahul Sekh (19) S/O Amir Hussain of Taranagar, Near Jama Masjid, PS Lalgola, Dist: Murshidabad along with following seized articles viz:

In this regard I, S.I Dawa Tshering Sherpa S/O Sri Mingma Sherpa of Bhaktinagar P.S. lodged a written complaint against the above noted accused persons to the effect that today on 22.12.2021 at 14:20 hrs received a information from SOG, SPC that two persons are waiting Near Gandhi Nagar Mart, NH 10, under Bhaktinagar PS, Dist: Jalpaiguri for someone along with one big white colour sack containing huge quantity of Ganja for clandestine disposal the same elsewhere at Siliguri area. He also stated that if they are not detained immediately they may leave for their destination. I accordingly

P.S G.D vide Bhaktinagar P.S. G.D.E. No. 1265 Dated. 22.12.2021. Accordingly in compliance with kind order of I/C Bhaktinagar PS and at 14.30 hrs myself along with A.S.I Rabin Lama, ASI Dipak Karmakar, CV 619 Dharmandra Roy left for Gandhi Nagar mart, NH 10 for working out the information, vide Bhaktinagar PS GDE No- 1266 Dt. 22.12.2021 at the time of departure I took all investigation kids like envelope, white paper, sealing wax, gum, seal, office weighing instrument etc.

At 14.45 hrs we reached at Gandhi Nagar Mart, NH 31, Siliguri and also contacted with SI Rajbihari Saha, and ASI Binod Jha of SOG, SPC and being shown and indicated by source I along with SOG, SPC detained the above accused persons who was standing at Gandhi Nagar mart, NH 10 and carrying big white colour plastic sack in hand of both accused persons, which was holding by both the accused persons. On being asked they disclosed their name and address as noted above and confessed that they have carrying Ganja for Clandestine disposal of the same elsewhere in Siliguri area. On demand they failed to produce any valid documents for carrying said Ganja. In the mean time, I called two local disinterested witnesses namely 1)Bablu Singh@Banti Singh (34) S/o Lt Krishna Prasad Singh of Mallaguri, new pokaijore, PS Pradhan Nagar, Dist. Darjeeling and 2) Mannu Sharma (34) s/o Gulab Sharma of Sastri Nagar, Iskon Mandir Road, PS Bhaktinagar Dist Jalpaiguri and requested them to present during search and seizure as witnesses and they agreed voluntarily. So, I detained the above noted accused persons. I immediately served Notice in writing to them, asking by who they wanted to be searched either Police Officer of Gazette rank or by Magistrate. They gave in writing that they could be searched by any one, I also offered them if they want to search police person but they denied to search to police. Further I informed the matter to I/C Bhaktinagar PS over Mobile Phone and requested him to requisite one Executive Magistrate through SDO Siliguri to remain present during search and seizure if any. Latter, I/C informed me over Telephone that he could not contact with SDO Siligiri and also other Executive Magistrate as they are engaged otherwise. As executive Magistrate could not available to remain present during search and seizure and also if accused persons are not searched immediately there was a escape with the illegal Ganja. So, I requested Sri Amaresh Singh I/C Bhaktinagar PS over Mobile phone to remain present as a Gazette officer during search and seizure. At 15.50 hrs I/C Bhaktinagar PS arrived at Gandhi Nagar Mart, NH 10. Under the supervision of I/C Bhaktinagar P.S I started the process of search & seizure. At first, I offered to both the accused persons if they want to search police person but they denied searching to police. So, in presence of Sri Amaresh Singh I/C Bhaktinagar PS and above two witnesses I searched their white colour big white Plastic sack holding by above accused persons on their right hand one by one and found two packets Ganja wrapped with brown colour plastic cello tape making it air tight.
