Which was seized from the sweet shop of Hansraj Prasad S/O Lt. Ramanand Prasad, shop styled as "Amrit Sweet" at Ramghat Road near Jalpaimore, PS Siliguri Dist Darjeeling.

I SI Goutam Kundu of E.B. SPC do hereby lodge this written complaint against the accused Hansraj Prasad S/O Lt. Ramanand POrasad, of Ramghat Road near Jalpaimore, PS Siliguri Dist Darjeeling, who was illegally procured domestic LPG cylinder and using the domestic Gas cylinder at his sweet shop as commercial purpose without any valid documents or license to the effect that today i.e. 21.12.21 at about 13.30 hrs. received an information from reliable source that one Hansraj Prasad S/O Lt. Ramanand Prasad, shop styled as "Armit Sweet" at Ramghat Road near Jalpaimore, PS Siliguri Dist Darjeeling using the domestic Gas cylinder in his sweet shop for commercial purpose for his illegal gain.

The matter informed to ACP EB SPC, as per his verbally direction I, along with SI Pradip Chakraborty, ASI Sailendra Nath Roy C/ 424 Manik Roy , CVF/ Debendra Nath Roy , all of EB, SPC informed the matter to Siliguri PS vide Siliguri PS GDE No 1300 dated 21.12.21 and accompanied with ASI Kalachand Singh C/239 Badal Barman C/ 466 Tarun Pahan all of Khalpara TGP, K-27 mobile Van officer & force has been to Ramghat Road near Jalpaimore , PS Siliguri, to work out the information. On the spot one local independence witness namely (1) Manajit Ghosh (44 yrs.) S/O Lt. Nani Gopal Ghosh and requested him to accompany with us during search and seizure, being shown and identify by the source I along with force and above noted independent witness entered into the sweet shop styled as "Armit Sweet" and during our search we recovered the above noted domestic Gas cylinder from his shop cum sweet preparing room which was using by the accused person for preparing sweet at his shop for commercial purpose. Seeing the presence of Police the shop owner Hansraj Prasad S/O Lt. Ramanand Prasad managed to fled away from his shop. But further local enquiry it is revealed that the owner Hansraj Prasad is using the domestic LPG for preparing sweet at his shop for commercial use without any valid document for his wrongful gain since long time.

The accused person used the domestic LPG cylinder with respect to fire or combustible matter in his sweet shop rashly and negligently which as to endanger in human life or to be likely to cause hurt or injury any other person at that locality.

Subsequently I seized the above noted articles under proper seizure list duly signed by the above noted witness (1) Manajit Ghosh (44 yrs.) S/O Lt. Nani Gopal Chosh and (2) ASI Sailendra nath Roy of EB SPC, as the owner of the shop or his representative did not appear to produce any valid documents in support of using the LPG cylinders at his sweet shop for commercial use. Seizure was made in between 14.55hrs to 15.25hrs)

Hence, I pray before you that a specific case may kindly be started against the accused person namely Hansraj Prasad S/O Lt Ramanand Prasad, shop styled as "Amrit Sweet" at Ramghat Road near Jalpaimore, PS Siliguri Dist Darjeeling under proper section of low and arrange for its investigation.
