With due respect and humble submission, in producing herewith one accused namely Pintu Oraon (32) S/O Lt Johan Oraon of Merry Road, Baghajotin Colony, Ward No.45, P.S-Pradhannagar, Dist.Darjeeling, under arrest along with following articles under proper seizure ;

- i) **11 (Eleven) Plastic bottles of Himalayan Gold, Country Spirit, 60* up each bottle containing 600 ML.**

I PSI Sumit Sarkar of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today on 23.12.2021 in course Special drive duty at PS area with force vide PDN PS GDE NO 1119 dtd.23.12.21, I received an information that one person namely Pintu Oraon is storing and selling liquor illegally in his house at Baghajotin Colony under Pradhannagar PS. Accordingly, I share the information to you and as per your kind instruction myself along with, CV/223 Swapan Chhetri, CV/645 Pankaj Gupta rush to the spot and as pointed by the source we apprehended the above noted person and on search his house & recovered above noted articles, On demand he failed to produce any valid document in respect of recovered articles. On interrogation he admitted that he is selling the same illegally without obtaining valid document for his illegal gain. Accordingly, I seized & label the above noted articles in between 20.05 hrs to 20.35 hrs and I arrested him.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Pintu Oraon (32) S/O Lt Johan Oraon of Merry Road, Baghajotin Colony, Ward No.45, P.S-Pradhannagar, Dist.Darjeeling and arrange for its investigation.
