Respected Sir,

With due respect, I, **Sri Gangadhar Agarwal**, Son of Late Bishwambar Dayal Agarwal, residing at Nehru Road, Khalpara, P.O. Siliguri Bazar, P.S. Siliguri, Dist. Darjeeling, beg to state as follows:

- 1) That I have purchased a piece of land measuring 0.08 acres, recrded in L.R. Khatian No. 598, L.R. Plot No. 436, under Mouza Kawakhari, J.L. No. 74, Police Station Matigara, Dist. Darjeeling by virtue of a registered deed of sale being no. 4274 for the year of 2008 which was executed on 14.05.2007 by Binod Adhikari and two others and registration was completed in the year of 2008 in the office of the Additional District Sub-Registrar Siliguri-II at Bagdogra and possession of the said land was delivered to and in favour of me.
- 2) That after purchasing the above mentioned land, my name has also been recorded in L.R. Khatian and L.R. Khatian being No. 3002 is opened in my name and I have been holding, occupying and enjoying the above mentioned land freely, openly and without any objection and interruption whatsoever.
- 3) That on 19.03.2020, when I along with my labours went to the above mentioned land for the purpose to cover the above mentioned land by constructing boundary wall at about 11:00 a.m., one Bablu Singha, Son of Niren Singha of Medical More, Kawakhari along with his mother and some others came to my above mentioned land and started to misbehave with me and obstruacted me from raising such construction and they illegally claimed that they are owners of the above mentioned land with an intention to extore money from me.
- 4) That thereafter, when I have shown my documents, said Bablu Singha and his mother threatened me and told that if I will not pay amount of Rs.50,00,000/- only to them, they will lodge false complaint against me and also to file case in the Court against me.
- 5) That thereafter on 20.03.2020, I have lodged a written complaint to you.

- 6) That subsequently, when the pandemic situation is normalized to some extent, in the month of January and February 2021, when I visited my above mentioned land, **Sri Niren Singha**, Son of Late Basua Singha, **Sri Nuken Singha**, Son of Late Basua Singha, **Sri Upen Singha**, Son of Late Basua Singha and said **Sri Bablu Singha**, Son of Niren Singha of Kawakhari, Medical More, P.O. Sushrutanagar, P.S. Matigara, Dist. Darjeeling threatened me with dire consequences and they have told that if I will not pay Rs.50,00,000/- only to them, they will not allow me to construct boundary wall.
- 7) That on 22.12.2021, when I along with my labours went to the above mentioned land for constructing boundary wall, the above named persons have forcibly restrained us and tried to assault us and threatened me that if I will not pay the said amount of Rs.50,00,000/- only to them, they will kill me and since 22.12.2021, the above named persons have been continuously threatening me by different means and they have also been looking for an opportunity to enter into my said land.

So, I therefore, request you to take necessary legal action against said **Sri Niren Singha**, Son of Late Basua Singha, **Sri Nuken Singha**, Son of Late Basua Singha, **Sri Upen Singha**, Son of Late Basua Singha and said **Sri Bablu Singha**, Son of Niren Singha of Kawakhari, Medical More, P.O. Sushrutanagar, P.S. Matigara, Dist. Darjeeling. And for this kindness, I shall much oblige to you.
