- That I have purchased a piece of land measuring 0.08 acres, recrded in L.R. Khatian No. 598, L.R. Plot No. 436, under Mouza Kawakhari, J.L. No. 74, Police Station Matigara, Dist. Darjeeling by virtue of a registered deed of sale being no. 4274 for the year of 2008 which was executed on 14.05.2007 by Binod Adhikari and two others and registration was completed in the year of 2008 in the office of the Additional District Sub-Registrar Siliguri-II at Bagdogra and possession of the said land was delivered to and in favour of me.
- That after purchasing the above mentioned land, my name has also been recorded in L.R. Khatian and L.R. Khatian being No. 3002 is opened in my name and I have been holding, occupying and enjoying the above mentioned land freely, openly and without any objection and interruption whatsoever.

- 5) That thereafter on 20.03.2020. I have lodged a written complaint to you.

So, I therefore, request you to take necessary legal action against said Sri Niren Singha, Son of Late Basua Singha, Sri Nuken Singha, Son of Late Basua Singha, Sri Upen Singha. Son of Late Basua Singha and said Sri Bablu Singha, Son of Niren Singha of Kawakhari, Medical More, P.O. Sushrutanagar, P.S. Matigara, Dist. Darjeeling. And for this kindness, I shall much oblige to you.
