I do here by lodge a specific case against the vehicle bearing No. HR 74 B 8600.

I, ASI Balai Ghosh of Bagdogra Trafice guard do hereby lodged this complain against the above noted vehicle to the effect that today on 24.12.2021 around 19.45 hrs while myself along with ASI Rajib Guha, C/513 Tapash Singha and CV 395 Ranjan Barman and CV 662 Jyotish Singha were performing traffic duty at Phansidewa under pass above noted vehicle came from Bagdogra side towards Siliguri with high speed. We try to stop the vehicle but he did not response and due to high speed and reckless driving of the driver of the vehicle bearing no. HR 74 B 8600 dashed to the height barrier of PWD at Phansidewa under pass for speed limit. But the above noted vehicle totally damaged the height barrier of PWD.
