I, SI Uday Chakraborty of Siliguri P.S. Siliguri Police Commissionerate, do hereby lodged this written complaint against namely; (1) Biswajit Mahanta @ Nasu (19 yrs) S/O Krishna Mahanta of Takkar Kalibusty, PS- Matigara, Dist- Darjeeling (2) Niki Das (19 yrs) S/O Jagannath Das of Thakkar, Diesel Colony, PS- Matigara, Dist- Darjeeling, (3) Md. Guddu (20 yrs) S/O Md. Samsul of Tulsi Nagar, PS- Matigara, Dist- Darjeeling, (4) Md. Bappa (21 yrs) S/O Md. Rafikul of Tikiapara, Prankrishna Colony, Ward No. 28, PS-Siliguri, Dist-Darjeeling, (5) Sanjib Das @ Velu (22 yrs) S/O Late Rabi Das of Tikiapara, Prankrishna Colony, Ward No. 28, PS- Siliguri, Dist- Darjeeling, and (6) Aloke Das (30 yrs)S/O Late Haran Das of Jyotinagar, Ward No. 04, PS- Siliguri, Dist- Darjeeling under arrest along with following seizure articles; (i) One (01) knife measuring approx. 12" including handle recovered from the possession of Biswajit Mahanta @ Nasu (knife was on his hand) (ii) One iron rod measuring approx. 28" pointed at one end (seemed to be implement of house breaking) recovered from Niki Das (iii) One Knife (Sharp Cutting weapon) measuring approx. 12" including its handle recovered from the possession of Md. Guddu, which he was holding on his hand, (iv) One house breaking Iron Rod measuring approx 18 "including handle recovered from the possession of Md. Bappa (v) One knife (sharp cutting weapon) measuring approx 12" including its handle recovered from the possession of Sanjib Das @ Velu.

In this regard, I beg to report that on 24.12.21 at 00:55 hrs received secret reliable source information that about 12/13 anti socials being armed with deadly weapons assembled at River Bed under the 4th Mahananda Bridge, Jyotinagar under Siliguri PS for making preparation to commit dacoity at Jyotinagar area. I informed this source information to IC Siliguri PS and noted the information vide Siliguri PS GDE No. 1492 Dated 24.12.21. As per the direction of IC Siliguri PS, at 01.05 hrs, I along with ASI Amar Raj Subba, ASI Siben Sarkar, ASI Subir Sen, ASI Dhruba Mishra, C/1183 Nikhil Saha, CV/05 Gobinda Das, CV/283 Prosenjit Dey, CV-622 Ramanath Barman left for River Bed under the 4th Mahananda Bridge, Jyotinagar under Siliguri PS for working out the information vide Siliguri PS GDE No. 1493 dated 24.12.21 after briefing officers and force properly and also along with required papers / articles. At 01.15 around hrs we reached at near River Bed under the 4th Mahananda Bridge, Jyotinagar under Siliguri PS and kept our vehicle at considerable distance. Then, I along with Officers and force headed towards River Bed under the 4th Mahananda Bridge, Jyotinagar under Siliguri PS looking for witnesses, if any on the way and found nothing. By this time we reached at River Bed under the 4th Mahananda Bridge, Jyotinagar under Siliguri PS, as

informed by secret source, we could see a group of persons standing and were whispering in subdued suspicious manner. On seeing us, they tried to flee away but somehow, above noted six persons could be apprehended and detained them. Then, after disclosing our identity, I asked them their motive to assemble at such a place and in such odd hours of night and in such a suspicious manner. On being asked they disclosed their names and address as noted above and admitted that they along with 6/7 others assembled at the spot making preparation to commit dacoity tonight at Jyotinagar area. I accordingly searched them in presence of witnesses and found; (i) One (01) knife measuring approx. 12" including handle recovered from the possession of Biswajit Mahanta @ Nasu (knife was on his hand) (ii) One iron rod measuring approx. 28" pointed at one end (seemed to be implement of house breaking) recovered from Niki Das (iii) One Knife (Sharp Cutting weapon) measuring approx. 12" including its handle recovered from the possession of Md. Guddu, which he was holding on his hand, (iv) One house breaking Iron Rod measuring approx 18 "including handle recovered from the possession of Md. Bappa (v) One knife (sharp cutting weapon) measuring approx 12" including its handle recovered from the possession of Sanjib Das @ Velu were making preparation for committing Dacoity tonight in Jyotinagar area but others managed to escape from the spot. Accordingly, I seized above noted weapons in presence of above mentioned witnesses under proper seizure list duly signed by them and labeled the same and arrested them informing them their ground of arrest preparing memo of arrest. The seizure and label was made in between 01.35 hrs to 02.35 hrs dated 24.12.21. On further interrogation the arrested accused persons also confessed that they along with others assembled at the spot for making preparation to commit Dacoity tonight in Jyotinagar area, but others managed to escape from the spot.

From the above noted facts, seizure and circumstance there is reason to believe that accused persons had assembled there with deadly weapons making preparation to commit dacoity at nearby Jyotinagar area.

Further, it to mention here that the arrested accused persons are well known anti social and have been indulged in many criminal cases.

Therefore, I pray before you to start a specific case against the above noted arrested accused persons & others 6/7 others who fled away under proper section of law and to cause its investigation.
