Sir,

I, SI Upendra Nath Roy of Siliguri P.S under Siliguri Police Commissionerate would like to lodge a written complaint against the Driver of vehicle (BOLERO CAMPER) bearing Reg. No- WB-73 D/4411. I beg to report that on 25.12.2021 at about 22.05 hrs, during my night Mobile Van duty, I was at Hill Cart Road near Venus More, under Siliguri PS area and found one white colour Bolero Camper Vehicle were coming from Tikiapara Flyover side with excessive speed and going towards Air View More side. I also found that the said vehicle rush and negligently damaged 10/12 numbers of Govt. Guard Rails and 02 numbers of Retro Reflective Drums which was placed over the Flyover for the purpose of smooth free flow trafficking. Huge Govt. money have loss due to damaged of above noted Govt. property. After that, said offending vehicle dashed one Scooty at Venus More. As a result, the rider of the said Scooty and his wife received grievous injuries on their persons and also damaged his Said Scooty. I along with my accompanied force tried to detain the vehicle but said vehicle fled away from the spot with high speed. I immediately rescued the injured persons and shifted them to Siliguri District Hospital for their treatment and then I along with my accompanied force again tried to apprehend the offending Driver of the said vehicle but in vain but I found that said vehicle again dashed another person at Hill Cart Road opposite SBI Mangaldip Branch. As a result, the said person received grievous bleeding injuries on his hand. I accordingly shifted him to Siliguri District Hospital and informed his relatives. The accused of the offending vehicle drove his vehicle in such rush and negligent having full knowledge that his such negligent and rush driving would have cause death of those victims.

Later, I came to learnt that the said vehicle also dashed few other persons in deferent places. During local enquiry and CCTV footage, I came to know the number of the said vehicle is WB-73 D/4411.

Under these circumstances, I pray that stern action may kindly be taken against the Driver of the offending vehicle (BOLERO CAMPER) bearing Reg. No- WB-73 D/4411 initiating a specific case under proper section of law.
