Sir,

In producing herewith one arrested accused persons namely Raj Kumar Tamang (40) S/O Lt Namgyal Tamang of H/No.147/1 Upper Boomtar, Namchi, P.S.-Namchi, Dist.South Sikkim, Sikkim and the following property under seizure along with seizure list:-

- (i) 150(One hundred Fifty) bottles of ONEREEX cough Syrup "Chlorpheniramine Maleate & Codeine Phosphate Syrup", each bottles contains 100 ml which contains Codeine Phosphate 10 mg each, kept in one maroon colour four wheeler trolley bag, named Styles as ARISTOCRAT, marked as Exhibit -"A"
- (ii) 01(One) bottles of ONEREEX cough Syrup "Chlorpheniramine Maleate & Codeine Phosphate Syrup", contains 100 ml which contains Codeine Phosphate 10 mg randomly taken from exhibit "A" for examination and marked as exhibit- A-1,
- (iii) 01(one) maroon colour four wheeler trolley bag, named Styles as ARISTOCRAT, marked as Exhibit -"B"

I, ASI Tarun Kanti Ghosh of Pradhan Nagar PS Siliguri Police Commissionerate do hereby submit this written complaint against above noted accused person the effect that on 28.12.2021 at 13:10 hrs, I received a reliable source information that one person standing at S.N.T bus stand, Siliguri Junction area under Pradhannagar PS with huge consignment of contraband cough syrup in his trolley bag for carrying the same illegally for supplying to Sikkim through vehicle.

The matter has been diarized vide Pradhan Nagar PS, GDE No. 1553 Dt- 28.12.2021 and I informed you and as per your direction myself along with PSI Sumit Sarkar, ASI Debasish Das, ASI Ashit Singha CV/242 Rakesh Mangar, CV/223 Swapan Chettri CV/128 Ajay Kr Sahani all of Pradhan Nagar PS Siliguri Police Commissionerate left for SNT Bus Stand by Govt. vehicle bearing no- WB-74AC 9851 to verify the veracity of the information accompanied by my source. This refers to Pradhan Nagar PS M.C.C No. 286/2021 Dt. 28.12.2021 which refers to Pradhan Nagar PS GDE no. 1554 Dt- 28.12.2021.

At the time of departure from the office, I took investigation kit and all necessary equipments. At about 13.35 hrs, we arrived inside the S.N.T bus stand, Siliguri Junction area under Pradhannagar PS and I contacted with two persons at S.N.T bus Stand and found two respectable persons namely (i) Sri Sagar Rasaily (49) S/O Lt Madan Kr Rasaily of Durgamandir, Kadamtala, P.S.-Matigara, Dist.Darjeeling Security Guard of SNT Bus Stand & (ii) Tek Bahadur Chettri (37) S/O Bhakta bahadur Chettri of Samdur, Ranipool, P.S.- Ranipool, Gangtok, Dist.East Sikkim canteen, owner of SNT bus stand. Then I informed them about the information in hand and requested them to accompany us in the whole process of search and seizure if necessary and as pointed by the source we found that one person standing at S.N.T bus stand with Trolley bag. Accordingly, we apprehended him. On being asked the apprehend person his identity as noted above. On further asked about the contains of his bag, he stated that its contains cough syrup for supply the same at Namchi, Sikkim through Customer.

Then we detained him with strong reason to believe that the said person is illegally possessing & transporting the contraband cough syrup inside his trolley bag. After disclosing our identity, I asked him in writing, whether he wants to be searched in presence of Executive Magistrate or Gazzetted officer for the process of Search and he agreed to be searched by Gazzetted officer. Subsequently, I contacted to the Sri Subhashis Chaki, I/C Pradhannagar PS SPC and requested to come to the spot and supervise the entire process of search and seizure as per law. Sri Subhashis Chaki, I/C PS SPC arrived at the spot at 14.15 hrs he discloses his identity before apprehended person as gazette officer and he has been offered to search the police team as well as gazette officer and witnesses, but he refused. Thereafter the process of the search was started.

Then under supervision of Sri Subhashis Chaki, I commenced search the trolley bag from his possession and found above noted contraband cough syrup. On asking he failed to produce any valid documents in support of the contraband cough syrup. Then I seized the above noted articles, throughout the sealing and labeling by preparing proper seizure list. The entire search, Seizure, label process has been made between 14.35 hrs to 15.25 hrs and arrested the apprehended person namely Raj Kumar Tamang (40) S/O Lt Namgyal Tamang of H/No.147/1 Upper Boomtar ,Namchi,Dist.South Sikkim for violating NDPS norms after maintaining all formalities regarding arrest. Further interrogation he admitted that he along with his associate involved in this crime.

Under the above circumstance, I pray before you to take the seized articles and sample & arrested accused persons namely Raj Kumar Tamang (40) S/O Lt Namgyal Tamang of H/No.147/1 Upper Boomtar ,Namchi,Dist.South Sikkim ,Sikkim & others and started a specific case against the arrested accused person under proper section of law and arrange for its investigation.
