In producing herewith one accused person namely Sanju Barman (22), S/O- Lt. Sashi Barman of Matigara Bazar, PO+PS- Matigara, Dist- Darjeeling along with seized articles viz., 1] 12 (twelve) bottles of Kingfisher Strong Premium Beer each bottle containing 650ml, total 7.8ml, value total Rs. 12X130=Rs. 1560/- and marked as 'exhibit -A' and 2] one bottle Kingfisher Strong premium Beer taken out from exhibit -A as sample for examination and marked as "exhibit A-1" I,PSI Shekhar Adhikary presently posted at Matigara Police Station, Siliguri Police Commissionerate would like to lodged this written complaint against the above noted person that today (30.12.2021) at 19.15 hrs onwards while performing Special raid duty, myself along with ASI Tapan Das, C/1035 Santosh Robidas and CV-387SukumarBarmanhad been to Matigara Bazar area and found that selling and storing of liquor was going on at the shop of the aforesaid person.
