In producing herewith one (01) arrested accused person namely Nandan Mohanto (20), S/O- Mantu Mohanto of Baniakari, Tripalijote PO- Nimai, PS- Matigara, Dist. - Darjeeling with the following articles under proper seizure as

- a) One multi colour bag containing 22 (Twenty Two) bottles of "CEFREX" Cough Syrup (each bottle containing 100 ml) having Batch No. TBHU 0232, Mfg. Date: 02/2021. Exp. Date: 01/2023 seized from the possession of above noted
- b) One (01) bottle of "CEFREX" Cough Syrup (containing 100 ml) randomly taken from "Exhibit- A" for examination
- I, SI Abhishek Theengh (32), S/O- Sri Suchandra Kumar Theengh of Matigara Police Station, Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted accused persons namely Nandan Mohanto (20), S/O- Mantu Mohanto of Baniakari, Tripalijote PO- Nimai, PS- Matigara, Dist. - Darjeeling to the effect that on 30.12.2021 at about 20:15 hrs I received a specific source input that one person possessing huge quantity of 'Codeine Phosphate' based drugs was standing at Tripalijote under Matigara PS to sell the same to their designed local customers. The matter was diarized in Matigara PS GDE No. 1527/21 Dt. 30.12.2021 and subsequently, I informed the matter to the Officer-in-Charge, Matigara Police Station in written and being directed, myself along with ASI Nitai Mandal, Const- 1035 Santosh Rabidas, Const- 1008 Kanak Roy and Const- 986 Rajib Sarkar, all of Matigara PS, SPC along with investigation kit left for Tripalijote under Matigara PS by Govt. vehicle to verify the veracity of the information. This refers to Matigara PS GDE No. 1528/21 Dt. 30.12.2021 and M.C.C No- 1364/021 Date-30.12.2021

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

On way to Tripalijote under Matigara PS, I contacted two persons namely (1) Golak Borai (42) s/o Lt. Bhim Borai of Simultala, PO New Rangia, Matigara, Dist Darjeeling and (2) Amal Biswas (52) s/o Lt. Santosh Biswas of Simultala, PO+PS Matigara, Dist Darjeeling and make them aware of the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed. Thereafter, we along with above noted independent witnesses arrived near Tripalijote, under PS- Matigara at 20.45 hrs and subsequently, being pointed by my source detained 01 (one) person standing near Tripalijote. He had carried one nylon bag under his possession. Thereafter, we disclosed our identity and the information in hand and stated him that he as well as the bag under his possession will be searched for the purpose. And, I gave him option in writing to be searched in presence of an Executive Magistrate or by any Gazetted Officer upon which he agreed to be searched in presence of any one of the above. I also offered the independent witnesses and the accused person to search our Police Party as per provisions but, he did not search the police party. Consequently, I informed the matter to O/C Matigara PS and as per his kind order, I informed to Shri Narendra Kalicotay, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC for the day, regarding the interception of the accused person suspected to be possessed 'Codeine Phosphate' based drugs illegally and requested him to come near Tripalijote under Matigara PS to remain present and to supervise the search and seizure.

Accordingly at 21:35 hrs Shri Narendra Kalicotay, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC arrived at the spot at Tripalijote under Matigara PS as Special Executive Magistrate, SPC and in presence of two independent witnesses I searched the detained person following all formalities, keeping his decency and recovered the above noted article from the exclusive and conscious possession of the accused namely Nandan Mohanto (20), S/O- Mantu Mohanto of Baniakari, Tripalijote PO- Nimai, PS- Matigara, Dist. - Darjeeling.

It has been found from the bag under the possession of the above noted accused person namely Nandan Mohanto containing 22 (twenty two) bottles of "CEFREX" cough syrup (each bottle containing 100 ml) containing 22 X 100 ml = 2200 ml i.e., equivalent to 2.2 Kg.

Further, on demand in presence of Shri Narendra Kalicotay, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC the detained persons namely Nandan Mohanto failed to produce any valid documents/papers or explanation for possessing of such a huge quantity of 'Codeine Phosphate' based drugs beyond the prescribed limit.

Thereafter, I seized the recovered 22 (twenty two) bottles [containing 2200 ml i.e., equivalent to 2.2 Kg] of FREX" Cough Symples of the containing 2200 ml i.e., equivalent to 2.2 kg. Subsequently, I labelled and sealed the seized articles in presence of Shri Narendra Kalicotay, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, SPC and independent with independent witnesses and the accused person namely Nandan Mahanto. The whole process of seizure was made in between 21.45 hrs to 22.25 hrs.

Being further asked, the apprehend person namely Nandan Mohanto admitted in presence of Shri Narendra Kalicotay, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC and other independent witnesses that he have procured the 'Codeine Phosphate' based drugs clandestinely for the purpose of selling the same in high rate to their designed local customer for his personal gain by illegal means. He also disclosed that he have been dealing in this business of procuring and selling of 'Codeine Phosphate' based drugs illegally for last few months for his wrongful gain.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused person namely Nandan Mohanto is involved in procuring and selling 'Codeine Phosphate' based drugs illegally contravening the norms of NDPS Act.

Then, I arrested the above noted accused person namely Nandan Mohanto after observing all formalities and informing the ground of their arrest and issued necessary Memo of Arrest.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused persons namely Nandan Mohanto (20), S/O- Mantu Mohanto of Baniakari, Tripalijote PO-Nimai, PS- Matigara, Dist. - Darjeeling and arrange for its investigation.
