Subject: Lodging of complaints due to violent activities & ruckus caused under Paramount Hospital premises

Respected Sir,

With due respect, I would like to bring it to your urgent notice that I, Ranajit Basak, S/o Mr. Santosh Basak residing at M.P. Road, Khalpara, P.O. & P.S. Siliguri, Dist. Darjeeling on behalf of Paramount Hospitals Pvt. Ltd., Siliguri, Dist. Darjeeling, would want to lodge a complaint against:

1. Mr. Vinit Bansal, S/o Mr. Binod Bansal
2. Mr. Anand Tebriwal, S/o Sanjay Tebriwal

That the above persons along with some anti-social persons, tried to enter the hospital premises forcefully destroying the assets and furniture of hospital and assaulted some of the staffs of hospital (Inzamam Haque S/o Mansur Ali and others) with blows and sticks, today, on 28/12/21 at about 2.30 PM., creating nuisance and disturbing the hospital peace and decorum. When our Senior Manager, Mr. Pintu Rustogi tried to stop them, they abused him, assaulted him with an intention to kill him. Somehow we managed to save him however they continuously threatened him and us that they will implicate him (Mr. Pintu Rustogi) in false cases and will kill him at any time outside the hospital.

These mentioned people have been repeatedly trying to cause nuisance in the hospital and have been violent in the past as well, despite of our security trying to restrain them. They blare their music & other related events at the top of the volume, causing severe disturbance for our critical patients, doctors, nurses,

and management, which causes a very negative and disturbing work environment.

Sir, I would also like to bring to your notice that their behaviour has also been very unacceptable towards our nurses as they have repeatedly been involved in Eve-teasing and uncomfortable attitude towards them, despite of frequent complaints. This has been very traumatizing for our female staff & nurses as it becomes very troublesome to travel to & fro the hospital.

As of today, on 28/12/2021 under the leadership of Mr. Vinit Bansal, Mr. Anand Tebriwal & others residing at Viswakarma Mandir Road, Khalpara, Siliguri, caused tremendous nuisance & chaos in our hospital, disturbing the peace & workflow of the entire hospital, patients & staff, as well as when I/we tried restraining them to cause such ruckus, they threatened me/us instead with dire consequences along with life threatens, if I/we would report the same to the law/authorities.

I feel that under such circumstances there is every possibility of repeated violence, disturbance & harm of peace & public tranquility.

Therefore, I/we request you to kindly investigate this matter and do the needful as per law. These people and associates have always been a big trouble and burden for us into the way of public medical services & hospitality.
