Respected Sir / Madam,

With due respect I, Smt. Manika Banik, W/o. Sri Swapan Banik, R/o. Sukanta Bhattacharya Sarani, Pareash Nagar, Sevoke Road, Ward No. 44, P.S. Bhaktinagar, Dist. Jalpaiguri would like to inform you that I am the sole owner of a homestead land measuring 0.0430 Acre, Vide R.S. Plot No. 378(P), Khatian No. 176, J.L. No. 02, Sheet No. 07, situated at Mouza. Dabgram, P.S. Bhaktinagar, Dist. Jalpaiguri, and Sub-Registration Office Jalpaiguri and I have been living there by constructing my dwelling house since long with my family members and I am also enjoying the physical possession of the said land (hereinafter called the below schedule land) and entrance of the said land belongs to a 6 ft. wide pucca road/passageway (Pucca Road also prepared by me) and I use the same regularly because without said 6 ft. wide pucca road (Pucca Road also prepared by me) I and my family members have no other entrance to enter my said dwelling house and I am enjoying the said entrance since 38 years without any disturbance of anyone and it is also important to mention here that I and my husband more than 20 years ago constructed one Well (KUAA) on the said road and I and my whole family members till now use the water of the said Well (Kuaa) on a regular basis.

It is pertinent to mention here that in the month of September my southern side neighbor namely Sri Prabir Das, S/o. Late Nipendra Chandra Das, R/o. above mention address after making some criminal conspiracy with my south-eastern corner neighbors namely Gopal Biswas, S/o. Late Girindra Chandra Biswas, Smt. Nitu Biswas, W/o. Sri Gopal Biswas, Sri Swapan Biswas, S/o. Late Girindra Chandra Biswas, Smt. Anjana Biswas, W/o. Sri Swapan Biswas, Sri Samar Biswas, S/o. Late Girindra Chandra Biswas, Sagar Biswas, S/o. Sri Samar Biswas, Sri Sekhar Biswas, S/o. Late Girindra Chandra Biswas, all of them are resident of:- above noted address, all of them trying to grab my aforesaid 6 ft. wide pucca road (Pucca Road also prepared by me) and also tried to break my aforesaid well (kuaa) and for that reasons they all of them on 29/09/2021 at about 06.30 PM, after making some criminal conspiracy among themselves against me and my family, all of them came to my house and told me that they want to use the aforesaid road after breaking their another side wall and they also told me that they will close the aforesaid well (Kuaa) and after that they all of them pressurized me to accept their proposal and give permission to them to use the said road as a common road but when I denied to accept their proposal at that time they became ferocious and started to use slang languages in respect of me and my family

members and till now they everyday tried to grab my aforesaid entrance road and also tried to close the aforesaid well (Kuaa) and till now I each and every day request them not to grab the same at that time they told me that they have a big channel in upper level and they will grab my entrance road by forcefully at any time and when I protested the same at that time they all of them also threatened me and my family members with dire consequences and told me that if I stop them to do the same then I will face serious consequences if I put any kind of obstruction at the time of doing the same.

Today (12/12/2021) at 2 PM, they all came again and broke a part of their respective walls to construct some gate to breach my passage. They even broke my KUAA which I had already covered with a concrete slab. **Gopal Biswas** along with **Nitu Biswas** even physically assaulted me by pushing, kicking, slapping, pulling my hair and intentionally outraged my modesty. They both and others around her hurled foul languages at me as they kept assaulting me and then my family members. **Nitu Biswas** and **Sagar Biswas** even tried to snatch my son's phone and hurled foul languages at him as he was making a video of their wrongdoing. They brought in my east side neighbour (**Bipul Sutradhar**, S/o. Palan Sutradhar) and forced him to break his small wall (hardly 2.5 feet) to make his gate too on this passage. Please note that this 6 ft. passage is being solely used by me for the last 38 years and today they deliberately and with all malintent demolished my source of water (KUAA). Along with the physical harm inflicted on me and my family members today, they threatened me with dire consequences that they will use their higher channels to harm me and my family any day and we should be in their fear always.

Therefore, I request you to please enquire into the matter and take necessary legal action against them as early as possible.
