Sir,

In producing herewith the eighteen (03) arrested accused persons namely;  
i) Ranjit Biswas (50 yrs) S/O Late Hem Biswas of Sarbohara Colony, Ward No. 28, PS-Siliguri, Dist- Darjeeling, ii) Dulal Biswas (52 yrs) S/O Late Hem Biswas of do and iii) Raju Biswas (23 yrs) S/O Late Mihir Biswas of do along with seized articles seized from the joint possession of the above noted accused persons viz (a) 04 nos. of counting in their respective names note book, ii) 02 pair of Playing cards, iii) 03 nos. of ball pen, iv) Cash RS 4716/- ( four thousands seven hundred sixteen only) as board money, ( v ) one plastic made sheet as per seizure list,

I, SI Uday Chakraborty of Siliguri PS lodged a written complaint against i) Ranjit Biswas (50 yrs) S/O Late Hem Biswas of Sarbohara Colony, Ward No. 28, PS-Siliguri, Dist- Darjeeling, ii) Dulal Biswas (52 yrs) S/O Late Hem Biswas of do and iii) Raju Biswas (23 yrs) S/O Late Mihir Biswas of do that on 30.12.21 at 15.25 hrs received an information from secret source over telephone that a gambling with cards is going on inside the house of Ranjit Biswas of Sarbohara Colony, Ward No. 28, PS-Siliguri, Dist- Darjeeling and the fact was diarized vide Siliguri PS GDE no. 1925 dt 30.12.2021. The matter was accordingly informed to I.C of Siliguri PS and being directed by him, I along with ASI Subir Sen, ASI Siben Sarkar, CV/283 Prosenjit Dey, CV/622 Ramanath Barman left for Sarbohara Colony under Siliguri PS to work out the information vide Siliguri PS G.D.E No. 1926 dated 30.12.21. At 15.55 hrs after reaching there and prior to the entering inside the house we summoned two available local witnesses namely 1) Gouranga Sarkar (54) S/O Late Abinash Sarkar of Lichu bagan, Subhashpally, Ward No. 18, PS-Siliguri Dist- Darjeeling, 2) Mridul Biswas (46) S/O Late Mahendra Biswas of Sarbohara Colony, Ward No. 28, PS- Siliguri, Dist- Darjeeling and requested them to be present with us during raid and cordoning the house of Ranjit Biswas being identified by the source with a strong reason to believe that a illegal gambling is going on inside and managed to apprehend them. Then we found that the above noted arrested persons were gambling with the help of playing cards and money for wrongful gain and wrongful loss to each other inside the above mentioned house. On interrogation they disclosed their identity as noted above.
