Sir/Madam,

I hereby wants to inform you that,
today when I was alone along with my daughter in
law and her small kid, around 11:00 am Mahesh Prasad
Rai, younger son of Mishri Lal Rai resident of Lala Basti
P.O f P.S Bagdogra with two other unknown persons
forcefully tries to enter my premises by continuously
knocking the gate and while enquiry he said that
open the door I am owner of this house, while
opposing that, he started uttering slang/bad words
to open the gate and tried to break open the
gate, when I resisted then he used slang language

"Saali, Kuliya, horami jaldi derwaya khad warna
gate tar durga" I was helpless and immediately
called up my younger son, who was in office to
come home and told the incident after this
Mahesh Rasasad Rai left and after 10 minutes
he came with my second son Dhermerda
Nath & his brother Dipak who also used, uttered
several explicit remark against me and my
daughter in law of dire consequences, threatening
me of beating and after that both of them
left the house.

On 22nd December 2021 also Mahesh ^{Present} Rai, with
his son Arvind along with Dhermerda Nath did
the same thing of threatening to my younger
son Nagerendra Nath Gupta of dire consequences.

Mahesh Present Rai & Dhermerda Nath is
continuously threatening & disturbing ~~my~~ me resulting
in deteriorating my health and mental peace

It is my humble prayer before you to
kindly take the strongest possible legal
action against the above named persons.
