With due respect and humble submission, in producing herewith one arrested accused namely Kumar Bahadur Rana S/o Lt. Tek Bahadur Rana of Diesel Colony near Kalimandir Mandir PS-Pradhan Nagar Dist Darjeeling under arrest along with following seized articles under proper seizure;

- i) 20(Twenty)bottles of Himalayan Gold country Spirit 60*up each bottle contains @ 300 ml each.
- ii) 03(Three) bottles of EMBOSS Fine Whisky each bottle contains 750 ml.

I ASI Debasish Das of Pradhanagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today on 30.12.21 when I along with CV/223 Swapan Chettri,CV/992 Jagadish Biswas was performing Special Drive duty vide PDN PS GDE NO 1681 dtd 30.12.21 .I received an information that one person namely Kamal Bahadur Rana has storage huge quantity of illegal liquor in his Tea stall at Diesel Colony under Pradhanagar PS, Dist Darjeeling and selling the same in his Tea stall. Accordingly, I share the information to you and as per your kind instruction myself along with force rush to the spot and held raid in the shop noted above and detained the above noted person and on search his Tea stall and recovered above noted articles, On demand he failed to produce any valid document in respect of recovered articles .On interrogation he admitted that he is selling the same illegally without obtaining valid document for his illegal gain. Accordingly, I seized & label the above noted articles in between 15:35 hrs to 16:20 hrs and I arrested him after maintaining all formalities regarding arrest.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Kumar Bahadur Rana S/o Lt. Tek Bahadur Rana of Diesel Colony near Kalimandir Mandir PS-Pradhan Nagar Dist Darjeeling and arrange for its investigation.
