In producing herewith 02 (Two) arrested accused persons namely (i) Sabir Hussain (42 yrs) S/O Jumman Ali of Vill- Alipur Bhur Sarki, Dhakka More, PS- Saidnagli, Dist.- JP Nagar Amroha, Uttar Pradesh (ii) Md Nasir Ali (31 yrs) S/O Md Mujahid Hussain of Vill- Kherpur, PS- Asmoli, Dist.- Sambhal, Uttar Pradesh and the following articles under seizure viz:-

1) One Truck displaying number plate UP/23/T/9125 loaded with Teak timber total 80 loges (measurement mentioned in seizure list)

I, ASI Khagen Barman of NJP PS, SPC do hereby lodge this complaint against the above noted arrested 02 (two) accused persons that today i.e. on 30.12.21 at about 16.10 .hrs I received a secret source information that one truck displaying number plate UP/23/T/9125 is coming from Assam side and proceeded towards Kolkata which is loaded with huge quantity of stolen timber (Teak logs). Accordingly, I informed the fact to you and diarised the fact in General diary vide NJP PS GDE No 1910 dated 30.12.21 and as per your kind direction myself along with ASI Sajal Das, C/1053 Paresh Rava, VP/08 Laxman Roy, VP/13 Jamirul Islam CV/306 Biswajit Roy left for Jatikali More to verify the veracity of the information information in hand. Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender. At 16.35 hrs we arrived at Jatiakali More and started to Naka Checking at Jatiakali More. At about 16.55 hrs we managed to intercept the said truck displaying number plate UP/23/T/9125 at under NJP PS and found two persons seating inside the vehicle Jatiakali More including the driver of the said vehicle. On being asked the driver of the said vehicle disclosed his identity as Sabir Hussain (42 yrs) S/O Jumman Ali of Vill- Alipur Bhur Sarki, Dhakka More, PS- Saidnagli, Dist.- JP Nagar Amroha, Uttar Pradesh and Co-driver disclosed his identity as Md Nasir Ali (31 yrs) S/O Md Mujahid Hussain of Vill- Kherpur, PS- Asmoli, Dist.- Sambhal, Uttar Pradesh. Subsequently, we searched the vehicle and found huge number of Teak logs loaded in the said vehicle. On counting it is found that the vehicle loaded with total 80 (Eighty) numbers of loges of tick timber measuring approx total 460.93 CFT.

On demand the above noted accused persons failed to produce any valid documents in respect of the above noted Teak logs loaded in their vehicle as well as failed to produce any documents in respect of the vehicle. Being further interrogated they disclosed that they in connivance with others and after getting permission of the truck owner they have procured the teak logs clandestinely from Assam by illegal way with a view to sell the same in Kolkata for their personal gain.
