Irsad (30yrs) s/o Lt. Md. Mamta of Rajahali ,PS- NJP Dist- Jalpaiguri (ii) Sandip Adhikary (32yrs) s/o Ranjit Adhikary of vill- Dinhatta ,PS- Dinhatta Dist- Coochbehar (iii) Chandan Kumar (19yrs) s/o Lalbihari of Dhali bazar ,PS- Sakra Dist- Mujafarpur (Bihar)(iv) Tanjay Dutta (28yrs) s/o Parimal Dutta of Bhalomore ,PS- NJP Dist- Jalpaiguri(v) Biki Roy(30yrs) s/o Balmiki Roy of Janatapara ,PS- NJP Dist- Darjeeling (vi) Md. Guddu (25yrs) s/o Md. Ekbal of Rajahali NR Maszid ,PS- NJP Dist- Jalpaiguri (vii) Suhata sarakt (33yrs) s/o Subash Sarkar of Suryasen Colony, Block-E, PS- NJP Dist- Jalpaiguri and found that the above noted persons were gathered there without any reason and found them without wearing mask and also making unnecessary gathering at Gate Bazar . On interrogation they also stated that they were well aware of Govt. order regarding pandemic situations and wearing of facemasks was mandatory in public places in the current pandemic situation.


They all are violated the order of Govt. of West Bengal vide order No 753/XVII-ISS/2M-2/2020 Dated 02/01/2022 regarding pandemic situations. Hence, I arrested them under proper memo of arrest in between 20:25 Hrs and 21:05 Hrs and duly signed by them in presence of witnesses and inform the ground of arrest.


