In producing here with six arrested accused persons namely 1) Ashish Krowa s/oTufan Korwa of Singhania T.E, PS Birpara Dist Alipurduar 2) Chandan Roy (22) s/o Uma Roy of Mallaguri Tea Auction Road Pradhannagar Dist Darjeeling, 3) Ganesh Das (52) s/o Anil Das of Bagajatin Colony Ward No 45 Pradhannagar Dist Darjeeling 4) Rishad Ali (18) s/o Haider Ali of Singhania T.E, PS Birpara Dist Alipurduar, 5) Tapash kundu (42) s/o Subash Ch kundu of Champasari Anchal, Pradhannagar Dist Darjeeling. 6) Sagar Biswas s/o Susanta Biswas of Champasari Anchal, Pradhannagar Dist Darjeeling under arrested U/S 41 Cr.P.C and do hereby lodge a written complaint against them.

In this regard I beg to inform you that on 10.01.2022 while performing patrolling van duty received information that some persons were loitering without wearing mask at Champasari More area. I along with C/974 Mintu Sen and CV 993 Anil Das had been to Champasari More area and found that the above noted persons were gathering and loitering without wearing mask. They violated the order No.-753/XVI-ISS/2M-22/2020 dated 15/05/2021 and Notification number 347 -01.S.S / 2M-24/2020 dated 3rd June, 2020 and Memo No 486-CS/2021 dated 24th April, 2021 Promulgated by Govt. of West Bengal to combat with the spread of Covid-19. Finding no other alternative, along with force apprehended them and arrested them U/S 41C.rPC in between 17:05 hrs to 17:45 hrs. On interrogation, they disclosed their names and address as noted above. On further asking, they admitted that they were aware of the Lockdown Order and restrictions imposed upon the movement of general public and vehicle to combat against the spread of Covid-19.

I, therefore, pray before you that a specific case may kindly be started against above noted arrested accused persons and take lawful action.
