With due respect I Smt Nita Prasad W/O Sri. Dilip Prosad, would like to inform you that my husband is Prop. of D. K. Enterprise of Holding No. 7323/N, Shiv Nagar, Ward No. 46, P.S. Pradhannagar, Dist Darjeeling and on 01.10.2019 he took open space measuring about 4500 Sq. Ft. situates at Shiv Nagar, Ward No. 46, P.S. Pradhannagar, Dist. Darjeeling from one Bishwanath Saha, S/o Lt. Laxman Saha on a rent of Rs. 3000/- per month for keeping our bricks thereon. That after entered into a tenancy agreement with the land owner Bishwanath Saha hé used to keep our bricks on the tenanted space as godown and wherefrom he also run his business but on 09.09.2021 the aforesaid persons suddenly locked the main gate under a pad-lock and restrained my husband and also the land owner to enter into the said land, wherein a huge number of bricks (Approx. 1,64,386 piece of bricks) present market value of Rs. 12 Lacks approx. are stored. That after lock the said main gate he several times requested the aforesaid persons to open the gate to remove his bricks from there but they tried to extort him by saying that if I not given Rs. 2 lacks immediately then they will not allow him to remove the said bricks, as a result he sustained severe loss of his business. The aforesaid persons wrongfully restrained him to enter into his tenanted space and disturb his business and presently they hatched up a deep rooted conspiracy to misappropriate his entire bricks by illegal means. On 10.01.2022 at about 5:30 P.M. the aforesaid person forcibly entered into office premises along with another 3 /4 persons and took my husband's signature on a Rs. 10/- Non Judicial stamp Paper with 2 / 3 blank papers by showing Sharpe cutting weapons and hokey sticks by putting fear of death and also threatened him by saying that if he disclosed anything then they will kill him and his family. The aforesaid persons also hurling un parliamentary languages to him, however he digested the same because he thought good sense will come very soon, without this the landlord and his son Sabitra Saha @ Danu told him that they will convince the aforesaid persons to open the said gate but the aforesaid persons are very adamant and they did not pay any heed the words of landlord, more so on 10.1.2022 the aforesaid persons crossed their limit.
