In producing herewith two arrested accused persons namely 1) Ismail Hague 35 we s/o Md Alamgir R/o Bhundarugachh, Po, Nakugach Ps, Rajganj Dist, Jalpaiguri he worked as Civic Police no 10 posted at Rajganj Ps 2) Anup Mandal 46yrs s/o Santosh Ch Mandal R/o Santinagar PO+Ps, Haldibari Dist, Coochbehar along with the following seized articles viz

- i. One black color solid bust stone Antiques Idol lord Sree Vishnu measuring approx Length 18 inch approx and width 8 inch weight 7 kgs 783 grams, Market as Exhibit "A".
- One Two wheeler Motor Cycle Black color styled as Pulsar bearing registration no WB72K/2747.
- Three numbers of mobile hand set a) Samsung having connection no 9832639032&9434807738 b) NOKIA having connection no 9091787192&7001858282 and one Keypad mobile hand set having connection no 9635634394.
- iv. One black and orange color ransacked pittu bag styled as "ENERZAL".

I SI Bapi Ch Dey of Bagdogra Ps , Siliguri Police Commissionerate do here by lodged this complaint against the following arrested accused persons namely 1) Ismail Hague 35 yrs s/o Md Alamgir R/o Bhundarugachh, Po, Nakugach Ps, Rajganj Dist, Jalpaiguri worked as Civic Police no 10 posted at Rajganj Ps 2) Anup Mandal 46 yrs s/o Santosh Ch Mandal R/o Santinagar PO+Ps, Haldibari Dist, Coochbehar to the effect that on 12.01.22 at 19.10 hrs received a secret source information that two persons with black Pulsar Motor cycle were standing near Gossainpur Naka Point who have possessing one solid bust antiques stone Idol for clandestinely disposal of the same illegally. The matter was diarized vide Bagdogra Ps GDE No 1185 Dtd, 12.01.22. Accordingly, I informed the matter to O.C, Bagdogra PS and as per his instruction at 19.15 hrs myself along with SI Binup Mahato, ASI Dhirendra Nath Mandal , C/410 Montosh Singh, C/831Bishnu Das left for the spot to verify the veracity of the information vide corresponding Bagdogra Ps G.D.E. No. 1186 Dtd 12.01.22 and Bagdogra PS M.C.C No- 157/22 Dt.12.01.22. At the time of departure from Police Station, I bring weighing machine, envelope, paper, sealing wax, gum, seal etc. On way to spot at Gossinpur More meanwhile, I called two independent witnesses who were passing on the spot by bi-cycle namely 1) Kundan Kumar 25 yrs s/o Prem Kumar Routh R/o Upper Bagdogra Balaramnagar Ps Bagdogra Dist. Darjeeling 2) Md Ramjan 23yrs s/o Md Fakira R/o Upper Bagdogra Panighata More Ps Bagdogra Dist. Darjeeling informed them about them regarding information in hand and requested them to accompany us to witness the search and seizure if necessary. At about 19.35 hrs on arrival there by govt. vehicle as identified by the source we surrounded the place and found two persons sitting on a black color Motorcycle styled as Pulsar RC no WB72K/2747 at Gosainpur near Naka point, seeing the police party they started the motorcycle and tried to flee away. On hot chase, we apprehended both the persons with the said Motorcycle. On being asked they disclosed their identity as noted above. After disclosing our identity as well as the fact, I asked them whether they wanted to be searched me or my police party but they denied to to the same.

Then in presence of independent witnesses, I conducted searched the black and orange color ransacked pittu bag styled as "ENERZAL" which was carried by them and recovered one black color solid bust stone Antiques Idol lord Sree Vishnu measuring approx Length 18 inch approx and width 8 inch on weighing by the weight machine total 7 kgs 783 grams. On interrogation Ismail Hague confessed that the Antiques Idol lord Sree Vishnu he received from one Mr Partha Das who was residing at Deshbandhu Para Siliguri for the purpose of selling as a huge amount to his designated customers Anup Mandal on further interrogation Anup Mandal confessed that he arrange the following customers namely Tapash, Ramu, Atul and one Nepali community male person for selling the same Antiques Idol lord Sree Vishnu as a amount of rate of Rupees Four Crore and the selling amount of rupees they three divided among each others. On demand in presence of the independent witnesses they failed to produce any valid document in support of carrying and possessing of the same huge amount of Antiques Idol lord Sree Vishnu.

Then, I arrest the above noted two accused persons u/s-41 Cr.P.C after observing all formalities of arrest as well as after disclosing the cause of arrest and issued Memo of Arrest. The copy of seizure list and Memo of Arrest has been supplied to them under proper receipt as the accused persons violated the terms and condition of dishonestly dealing & concealment of valuable stolen property of Antiquities and Art Treasury Act, 1972. The seizure and arrest was made between 19.55 to hrs to 20.45 hrs.

Under the above circumstances, I pray to you that a specific case under proper section of Law may kindly be started against the accused persons namely 1) Ismail Hague 35yrs s/o Md Alamgir R/o Bhundarugachh, Po, Nakugach Ps, Rajganj Dist, Jalpaiguri he worked as Civic Police no 10 posted at Rajganj Ps 2) Anup Mandal 46yrs s/o Satish Ch Mandal R/o Santinagar Ps, Haldibari Dist, Coochbehar 3) Partha Das R/o Deshbandhu Para Siliguri 4) Tapash, 5) Ramu, 6) Atul and 7) one Nepali community
