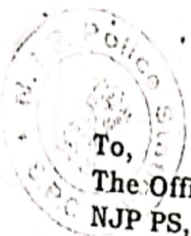

Sir,

With due respect, I am producing herewith one arrested accused person namely Ujjal Paul (37 yrs) S/O late Radhesh Paul of Janata Para, Ward No- 35, PS- NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 15 (Fifteen) bottles of 60 Up Himalayan Gold Country Spirit containing 600 ML in each bottle.
2. 01 (One) bottle of HAYWARDS 5000 super Strong Beer containing 650 ML.
3. 02 (Two) bottles of COSMOS FIFTY Deluxe Whisky containing 750 ML in each bottle.
4. 02 (Two) bottles of Imperial Blue Classic Grain Whisky Containing 180 ML in each bottle.

I, SI ASI Sajal Das presently attached with NJP PS under your kind control beg to state that today i.e. on 12.01.22 at 08.10 hrs I received a secret source information that one person namely Ujjal Paul of Janata Para, Ward No-35, PS- NJP, Dist.- Jalpaiguri is selling ID liquor illegally in his hotel at near Truck Stand, NJP for his illegal gain. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No 512 dated 12.01.22 and informed the fact to you. As per your kind direction and instruction myself along with C/1053 Paresh Rava, IIG/794 Ranjit Roy and others all of NJP PS, SPC left for NJP Truck Stand to work out the information in hand. At about 08.25 hrs we arrived near NJP Truck Stand and being identified by the source I held rald at the hotel of the above noted accued and managed to apprehended the owner of the said hotel. On being asked he disclosed his name and identity as noted above and also disclosed that he is selling ID liquor at his hotel since long for his illegal gain. On search the above noted I/D liquor recovered from his possession. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his shop. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between hrs 08.35 hrs to 09.05 hrs on 12.01.22.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Ujjal Paul (37 yrs) S/O late Radhesh Paul of Janata Para, Ward No- 35, PS- NJP, Dist.- Jalpaiguri and arrange for its investigation.
