The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. Accourding I arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.
