Ward No-25, Milanpally, PS- Siliguri, Dist-Darjeeling & (3) Sandeep Sharma (36) S/O Madanlal Sharma of Milanpally near Childrenpark, Ward No-25, PS- Siliguri, Dist-Darjeeling do hereby lodge complaint against the above noted arrested persons to the effect that, on 13.01.2022 at 10.45 hrs during my R/T Mobile Van duty had been to Milanpally, near Children Park, Siliguri and found the above noted persons were gathered/ roaming without wearing mask on their face and without any proper reasons.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
