That it has also come to my notice that the girls working in the call center were luring men by giving their forged identity with the malafied intention of procuring unlawful gains. That it has also come to my notice that the above named Sourav Ray and his associates has been running a call center and cheating people for his unlawful gain by making criminal conspiracy and forgery of

That unusual activities observed in regard to the business of above tenant include movement of a large no of girls to and fro from the said flat through out the entire day.

They have also violated the COVID guide lines of the Govt of West Bengal.

That the said Sourav Ray and his associates have also breached the very purpose for which the property was taken on rent thereby dettrimental to the very purpose for which the property was

Hence I request you to take strong and necessary action and protect my property from illegal and unlawful use.
