Thereby completely violating the lockdown measures issued by Chief Secretary West Bengal vide order no. 753/XV II-ISS/2M-22/2020 DTD.02/01/2022. On seeing police, they tried to flee away but somehow, the above noted person could be apprehended. On interrogation, they disclosed their name and address as noted above. On further interrogation, they admitted that they were aware of the lockdown Order and Restrictions imposed upon the movement of human being and shops. As he has violated the Lockdown Order promulgate by the appropriate Government Authority and also the provision of Disaster Management Act, 2005, I with the help of force arrested him U/S 41 CrPC by issuing him memo of arrest.

I, therefore pray that a specific case under proper section of law may kindly be initiated against the above noted arrested accused person.
