In producing herewith the one arrested accused person namely Joy Prakash Gupta 38yrs s/o Pumni Gupta of Laxmipur Ekdanga PS, Sindunia Dist, Maharajganj UP, PIN 273302 (Driver of the vehicle) along with the seized Vehicle eighteen wheeler bearing registration no . UP53BT/8736 (Multi Axel Trailer) loaded with stone chips, I beg to submit that today on 26.01.2022 at 22.15 hrs in course of my K-36 night mobile van duty, vide GDE No. 1984 dtd, 26.01.2022 along with force and as per secret source information we reached at Gossainpur near Naka checking post and found that the mentioned Vehicle RC No UP53BT/8736 eighteen wheeler was coming towards Shibmandir side along the road and intercepted the same. On searching, the said vehicle was fully found loaded with stone chips. On demand, the accused person Joy Prakash Gupta, the driver of Vehicle RC No UP53BT/8736 (Multi Axel Trailer) failed to produce any valid documents or license in support of him for lifting and transportation of the stone chips. So, there is sufficient ground to believe that the said loaded stone chips were taken either theft or any other fraudulent means and for which, I seized the Vehicle bearing RC No. UP53BT/8736 (Multi Axel Trailer) loaded with stone chips under proper seizure list maintaining all formalities, the seizure process was made in between 22.25 hrs to 22.55 hrs and subsequently arrested the accused person Joy Prakash Gupta u/s 41A CrPC observing all formalities and narrated him the ground of his arrest.

During interrogation, he confessed his guilt that he was carrying the sand loaded in said Vehicle being lifted from Birpara side Dist, Alipurduar for illegal gain without any valid document.

Under the above circumstances, I pray to your honour that a specific case under proper section of law, may kindly be registered against Joy Prakash Gupta 38yrs s/o Pumni Gupta of Laxmipur Ekdanga PS, Sindunia Dist, Maharajganj UP, PIN 273302 the driver of Vehicle RC No UP53BT/8736 (Multi Axel Trailer) and arrange for its investigation.
