Sir,

In producing herewith the one arrested accused person namely Kishan Sahani 21yrs (D/L No WB7320100345665 Driver of the vehicle) s/o Late Dipak Sahani of Matigara Baniyakhari Tripali Jote PS, Matigara Dist, Darjeeling along with the seized Vehicle bearing registration no WB73F/7639 (Dumper) loaded with undersize boulder, I beg to submit that on 27.01.2022 in course of my night special mobile van duty, vide GDE No. 1972 dtd, 27.01.2022 along with force and during night on 28.01.2022 around at 00.45 hrs and as per secret source information we reached at Gossainpur near Naka checking post and started search and found that the mentioned Vehicle WB73F/7639 (Dumper) was coming towards Matigara side along the road and intercepted the same. On searching, the said vehicle was found fully loaded with undersize boulder. On demand, the accused person Kishan Sahani driver of the Vehicle RC No WB73F/7639 (Dumper) failed to produce any valid documents or license in support of him for lifting and transportation of the under size boulder. So, there is sufficient ground to believe that the said loaded under size boulder were taken either theft or any other fraudulent means and for which, I seized the Vehicle bearing RC No. WB73F/7639 (Dumper) loaded with undersize boulder under proper seizure list maintaining all formalities, the seizure process was made in between 01.05 hrs to 01.45 hrs and subsequently arrested the accused person Kishan Sahani u/s 41A CrPC observing all formalities and narrated him the ground of his arrest.


During interrogation, he confessed his guilt that he was carrying the undersize boulder loaded in said Vehicle being lifted from Tarabari river ghat side for his illegal gain without any valid document.

Under the above circumstances, I pray to your honour that a specific case under proper section of law, may kindly be registered against Kishan Sahani 21yrs (D/L No WB7320100345665 Driver of the vehicle) s/o Late Dipak Sahani of Matigara Baniyakhari Tripali Jote PS, Matigara Dist, Darjeeling the driver of Vehicle RC No WB73F/7639 (Dumper) and arrange for its investigation.


