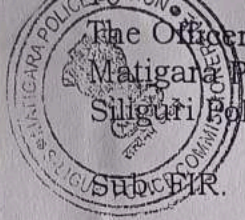

In producing herewith one accused person named Bhola Barman (32), S/O Hari Chandra Barman of Shantimoy Colony, Patiram Jote, PS-Matigara, Dist-Darjeeling under arrest along with following articles under proper seizure;

1] 12 (Twelve) bottles of Himalayan Gold 60 UP Country Spirit each bottle containing 600 ml (Total 600 ml X 12 = 7.2 Ltrs) and marked as "Exhibit A".

2] 01 (One) bottles of Himalayan Gold 60 UP Country Spirit containing 600 ml, taken out randomly from Exhibit A for examination and marked as Exhibit A-1.

I, SI Md. Sanaullah of Matigara PS SPC would like to lodged this written complaint against one accused person named Bhola Barman (32), S/O Hari Chandra Barman of Shantimoy Colony, Patiram Jote, PS-MTG, Dist-DJG to the effect that today on 29.01.2022 at about 21:00 hrs received source information that one person named Bhola Barman is selling liquor in a shop situated at Chourangi More, Patiramjote under Matigara PS area without any valid license. Accordingly, I informed the matter to the O/C PS and as per his kind direction I along with C/523 Sanjit Kundu, C/ 866 Dilip Barman had been to Patiramjote under Matigara PS to verify the veracity of source information. On reaching there and as identified by the source found that said person was selling and storing illicit liquor at his shop. Subsequently, I along with my force cordoned the house and was able to detain the above noted person. Subsequently, on being asked the apprehended person disclosed his name and identity as noted above and stated that he is the owner of the shop. Further being searched the above noted seized articles were found in the said shop. On demand he failed to produce any valid license/paper for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last 06 (six) months for his illegal gain. Then I seized and labeled the above mentioned illegal liquor under proper seizure list in presence of independent witnesses and arrested the above mentioned person named Bhola Barman (32), S/O Hari Chandra Barman of Shantimoy Colony, Patiram Jote, PS-Matigara, Dist-Darjeeling after observing all sort of formalities at the spot. The whole process of seizure and label has been made in between 21:15 hrs to 21:30 hrs as the spot and arrested him after informing the ground of arrest.

Therefore pray before your good self that a specific case may kindly be initiated against Bhola Barman (32), S/O Hari Chandra Barman of Shantimoy Colony, Patiram Jote, PS-Matigara, Dist-Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
