In producing herewith the one arrested accused person namely Bhanu Roy s/o Bachhav Roy R/o Kamala Bagan Ward no - 05 Hill Cart Road PS, Siliguri Dist, Darjeeling along with the seized Vehicle bearing registration no WB73G/0304 (Dumper) loaded with stone chips, I beg to submit that on 28.01.2022 in course of my K-35 night mobile van duty, vide GDE No. 2027 dtd, 28.01.2022 along with force around at 23.45 hrs and as per secret source information we reached at Gossainpur near Naka checking post and started search and found that the mentioned Vehicle WB73G/0304 (Dumper) was coming towards Matigara side along the road and intercepted the same. On searching, the said vehicle was found fully loaded with stone chips. On demand, the accused person Bhanu Roy driver of the Vehicle RC No WB73G/0304 (Dumper) failed to produce any valid documents or license in support of him for lifting and transportation of the stone chips. So, there is sufficient ground to believe that the said loaded stone chips were taken either theft or any other fraudulent means and for which, I seized the Vehicle bearing RC No. WB73G/0304 (Dumper) loaded with stone chips under proper seizure list maintaining all formalities, the seizure process was made in between 23.55 hrs to 00.25 hrs and subsequently arrested the accused person Bhanu Roy u/s 41A CrPC observing all formalities and narrated him the ground of his arrest.

During interrogation, he confessed his guilt that he was carrying the undersize boulder loaded in said Vehicle being lifted from Matigara side for his illegal gain without any valid document.
