Sir,

In producing here with five arrested accused persons namely 1) Bijay Kujur (25) s/o Lt. madan Kujur of Himkosh Bhawan, Kalkut, PS Pradhannagar Dist Darjeeling 2) Papai Das (23) s/o Nirmal Das of Baghajatin Colony near Mukta Manch PS Pradhannagar Dist Darjeeling 3) Nayan Gurung (28) s/o Sibam Gurung of Champasari Kalkut PS Pradhannagar Dist Darjeeling 4) Ganesh Chettri (30) s/o Gopal Chettri of Debidanga PS Pradhannagar Dist Darjeeling 5) Jayanta Roy (22) s/o Naresh Roy of Naya Bazar Gangarampur PS Gangarampur Dist Dakshin Dinajpur under arrested U/S 41 Cr.P.C and do hereby I SI Dilip Kr Paul lodge a written complaint against them.

In this regard I beg to inform you that on 25.01.2022 while performing patrolling van duty received information that some persons were loitering without wearing mask at Champasari More area. I along with C/858 Niranjan Sarkar and C/836 Sangit Chettri had been to Champasari More area and found that the above noted persons were gathering and loitering without wearing mask. They violated the order No.-753/XVI-ISS/2M-22/2020 dated 15/05/2021 and Notification number 347 - 01.S.S / 2M-24/2020 dated 3rd June, 2020 and Memo No 486-CS/2021 dated 24th April, 2021 Promulgated by Govt. of West Bengal to combat with the spread of Covid-19. Finding no other alternative, along with force apprehended them and arrested them U/S 41 Cr.P.C in between 19.10 hrs to 19.45 hrs. On interrogation, they disclosed their names and address as noted above. On further asking, they admitted that they were aware of the Lockdown Order and restrictions imposed upon the movement of general public and vehicle to combat against the spread of Covid-19.

I, therefore, pray before you that a specific case may kindly be started against above noted arrested accused persons and take lawful action.

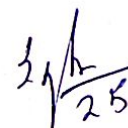
