Ltd of Chandigarh, has been sent to Siliguri by company for company's business dealing purposes. Here I was instructed to load our company's purchased goods to the particular vehicles from my company. But whenever I've tried to load these vehicles, two guys namely Rehan and Rohit Singh with some local goons has restrained and stopped us to load goods to the vehicles and threatened us if we want to run business here in Siliguri, we have to pay for it to them as local tax and extortion money otherwise they wouldn't release our goods amounted 6 crore.
