I, ASI Raju Subba of New Jalpaiguri Police Station, SPC do here by lodged this written complaint against the above noted persons to the effect that today (23/01/22) in between 19:15 Hrs and 20:35 Hrs in course of performing evening C/S mobile duty I along with force went Fulbari More area ,PS- NJP , Jalpaiguri and found as (1) Raju Sarkar (31yrs) S/o. Naresh Sarkar of Jyotirmoy Colony, PS. NJP, Dist-Jalpaiguri (2) Uttam Saha (42 yrs) S/o. Biren Saha of Battalion More, PO. Fulbari, PS. NJP, Dist-Jalpaiguri (3) Mihir Shaw (32 yrs) S/o. Late Sukdev Shaw , of Battalion More, PO. Fulbari, PS. NJP, Dist-Jalpaiguri (4) Mithilesh Mahata (24yrs), S/o Rajendra Mahata of Chakmadua, PS. Saraia, Dist-Mujaffarpur , Bihar (5) Nihar Akter (27 yrs), S/o. Md. Alam of Barsai,, Marnapur , PS. Barsai, Dist-Katihar, Bihar were gathered there without any reason and found them without wearing mask and also making unnecessary gathering at Fulbari More area. On interrogation they also stated that they were well aware of Govt: order regarding pandemic situations and wearing of facemasks was mandatory in public places in the current pandemic situation.

They all are violated the order of Govt. of West Bengal vide Memo No 753/XVII-ISS/2M-22/2029 Dtd. 02/01/2022 regarding pandemic situations.. Hence, I arrested them under proper memo of arrest in between 19:15 Hrs and 20:35 Hrs and duly signed by them in presence of witnesses and inform the ground of arrest.

Hence, I, request you for starting a specific case U/S 188/269/270 IPC r/w sec 51 (b) of disaster Management Act.2005 against the above noted accused persons and arrange proper investigation of the case.
