Sir,

In producing herewith one arrested accused person namely Rajkumar Sarkar (32 yrs), s/o - Santi Sarkar of 18 no Milanpally, PO- Milanpally, PS- NJP, Dist- Jalpaiguri under arrest along with seized articles viz. (i) 12 (twelve) bottles of Himalayan Gold 60 up Country Sprit, each bottle containing 600 ml. I ASI Sanjoy Saha of Milanpally OP under NJP PS do here by lodged a written complaint to the effect that today on 01/02/2022 at 18.15 hrs acting on a tip-off source information myself along with ASI Dipak Singh, C/694- Sushil Saibo, NVF/204 - Ajimul Haque had been to 18 No Milanpally under Milanpally OP in a PS govt. Vehicle to work out the information that a huge number of country spirit are stocked in the house of one Rajkumar Sarkar (32 yrs), s/o - Santi Sarkar of 18 no Milanpally, PO- Milanpally, PS- NJP, Dist- Jalpaiguri without license to sale the same in the open market. This refers to Milanpally OP GDE No- 21, DT-01/02/2022. On arrival at 18 No Milanpally at 18.30 hrs and I summoned two local witnesses to witness the raid and on being identified by the engaged source we held raid in the house of Rajkumar Sarkar and could recover the above noted of liquor. During raid the above noted accused person was arrested from whose exclusive possession the above noted liquors were found. On demand he could not produce any license/documents in support of his possession. On interrogation he admitted that he has been running the business clandestinely since long. Accordingly I seized the above noted liquors under proper seizure list and arrested the accused person U/S - 41 Cr.P.C and took him into the custody. The seizure was made in between 18.45 hrs to 19.05 hrs.

Hence, I pray that a specific case under proper section of law may kindly be Initiated against the accused person namely Rajkumar Sarkar (32 yrs), s/o - Santi Sarkar of 18 no Milanpally, PO- Milanpally, PS- NJP, Dist- Jalpaiguri.
