Dear Sir,

I Sri. Sanjay Mitra S/o., Lt. Shantimoy Mitra, resident of Kumkum, APC Sarani (Lower), Deshbandhu Para, Siliguri, Pin Code 734004, regret to state that Mr. Chiranjit Modak S/o. Dilip Modak Resident of Jaygir Bala Bari, Chowdhury Hat, Dinhata II, Coochbehar, West Bengal, 736166, (Aadhar Card No. 344425451480) & his wife Mrs. Champa Modak has been working in my company [SHIV SHAKTI TRADERS] as Godown and Showroom In charge respectively, since last 5 Years. On Friday i.e. 28.01.2022, Morning Mr. Chiranjit Modak came down to my residence early morning saying that his maternal uncle expired and he & his wife will have to leave Siliguri immediately for his hometown and handed over the keys of my showroom and godown and promised me to come back by Tuesday i.e. 01.02.2022. and reopen the showroom and godown. While going they carried our official mobile along with sim card no. 7557086898 of our company. We waited for them to arrive but all in vain.

Doubting their attitude we reached their rented room at Baneswar More, EM Bypass, and was surprised to know that they left the room on 28.01.2022. morning along with all their belongings in a very short time without any intimation.

Yesterday when we opened our Godown situated at Sarada More, Jaleswari Bazaar, Eastern Bypass, and tallied our stocks day long we found that five [05] E-Rickshaw Vehicles of ARROW EV-11, Bearing:-

1. Chassis No. MD9AERC21EH231840, Engine No. EVM013422
2. Chassis No. MD9AERC21EH231888, Engine No. EVM013131
3. Chassis No. MD9AERC21EH231809, Engine No. EVM013527
4. Chassis No. MD9AERC21EH231846, Engine No. EVM013533
5. Chassis No. MD9AERC21EH231772, Engine No. EVM013134

And Three [03] ARROW Loader motor, 22 Rings & Tires, all being missing from our Godown custody. Being the custodian of our godown & showroom respectively (Mr. Chiranjit Modak & Mrs. Champa Modak) we came to the conclusion that the above mention persons are directly involved and liable for this henerous act performed intentionally. You are thereby requested to Lodge an FIR against the said Persons and take all necessary steps from your end, so that I can recover my missing E-Rickshaws & Spare Parts with your co-operation at the earliest possible.
