Respected Sir/Ma'am,

I, Sri Bapi Samuel, S/O Late Peter Bansriar, resident of Military Road, Chaitanyapur P.O. New Rangia would like to bring under your kind notice that my daughter, Mrinalini Samuel (13 years old) was assaulted by two miscreants on a motorbike while on her way to her tuition near Yakthung Manpower and Security Services on 07/02/2022 at about 3:50 pm.

Mrinalini was on her way to tuition like on a regular day with her cousin brother, Pratyush Rai (12 years old). When they reached Jit Sun Hardware Store in Halermatha, two men with helmets on a motor bike called out my daughter. When she turned to look back, the pillion rider threw an unknown powder like substance on her face and fled away on the overspeeding bike. This happened between the time frame of 3.50 pm - 4:10 pm.

The unknown substance spiked both her eyes. It was also inhaled by her through the nose. Immediately Mrinalini's eyes started stinging painfully and within a matter of minutes, she started feeling nausea and dizziness. While her brother, Pratyush informed the family members about the incident, her symptoms advanced. Mrinalini could not open her eyes because of the pain and she went through intense giddiness and repeated vommiting.

In a precarious condition, she was rushed to Mukta Medical Hall in Shivamandir by the family and later to the ophthalmologist who extracted all the particles that obstructed her vision and provided required medication. The infection of eye had already started to occur on both sides.

You may be informed that this has caused great apprehension in the mind of my daughter. This incident has shown that it is a general danger to the girls walking on the road and attempt should be made to curb further incidents of such kind which instills trauma and fear in the mind of such young girls. This may be treated as extremely serious and action may kindly be taken immediately. For your information, the delay in filing a complaint is due to the medical treatment of my daughter.

In all probabilities, the footage of the incident is caught on the CCTV cameras affixed at the residence of the owner of Ashru Medical Hall in Leninpur. I request you to investigate further on this matter and proceed with necessary action to identify the perpetrators.
