Indajau Hoque of Maharalla Busty PS-Chopra, Dist-Uttar Dinajpur, 3) Suman Das (20) s/o Sahadeb Das of Narmada Bagan, Ward No 46 PS-Pradhan Nagar, Dist-Darjeeling, 4) Sanju Roy (30) s/o Babulal Roy of Natun Par Ramghat More, PS-Siliguri, Dist-Darjeling, 5) Bapi Barui (34) s/o Haripada Barui of Kafia jote Naxalbari, Ps-Naxalbari, Dist-Darjeeling, under arrested U/S 41 Cr.P.C and do hereby I SI Dilip Kr. Paul lodge a written complaint against them.

In this regard I beg to inform you that on 06.02.2022 while performing patrolling van duty received information that some persons were loitering without wearing mask at Champsari More area. I along with C/207 Niladri Sarkar and C/880 Pradip Ch. Roy had been to Champasari More area and found that the above noted persons were gathering and loitering without wearing mask. They violated the order No.-753/XVI-ISS/2M-22/2020 dated 15/05/2021 and Notification number 347 -01.S.S / 2M-24/2020 dated 3rd June, 2020 and Memo No 486-CS/2021 dated 24th April, 2021 Promulgated by Govt. of West Bengal to combat with the spread of Covid-19. Finding no other alternative, along with force apprehended them and arrested them U/S 41 Cr PC in between 20:35 hrs to 21:05 hrs. On interrogation, they disclosed their names and address as noted above. On further asking, they admitted that they were aware of the Lockdown Order and restrictions imposed upon the movement of general public and vehicle to combat against the spread of Covid-19.

I, therefore, pray before you that a specific case may kindly be started against above noted arrested accused persons and take lawful action.
