Sir,

In producing herewith one male accused person namely Rabi Paswan(26yrs.),S/O Punit Paswan of Santoshinagar near Machli More,W/No-05,PS-sSiliguri,Dist-Darjeeling along with the following seized articles as per proper seizer list.

1.22(Twenty Two) bottles of Himalaya Gold 60up premium country spirit ( each bottles containing 600ml. & MRP Rs 120/-)

I ASI Sanjay Hasda of Khalpara TOP under Siliguri Police Commissionerate lodge a written complaint against the above noted person to the effect that on 02.02.2022 at 14:25 hrs. received an information from Santoshinagar near Machli More,W/No-05,PS-sSiliguri,Dist-Darjeeling that one person has gathered huge quantity of illegal liquor which was kept in his house one gunny bag for selling the same in the open market for his wrong full gain. Diarized the fact in GD vide Khalpara TOP GDE NO -46/22, Dated-02.02.2022. As per your kind instruction myself along with ASI Md. Jinnat Ali, C/1183 Nikhil Saha, C/ 516 Sunil Roy and proceeded to the PO to work out the information . At 14:45 hrs. we reached at the Santoshinagar near Machli More,W/No-05,sometimes after being identified by the source our police party held raid and recovered the above noted articles from the possession of above referred person. On demand he could not produced any valid license/documents in support of said liquor. he become nervous and admitted his guilt before us and stated that he sell same in open marked for his wrong full gain. In presence of witnesses I seized the above noted articles from his possession after prepared proper seizer list and level and took signature of the accused person one bottles taken as sample.

(The seizure was made in between 15:05hrs. to 15:45hrs.) I arrested the accused person U/S 41 Cr. P.C and issued Memo of arrest.

I therefore request you a specific case may kindly be started against the accused person namely Rabi Paswan(26yrs.),S/O-Punit Oaswan of Santoshinagar near Machli More,W/No-05,PS-sSiliguri,Dist-Darjeeling under proper section of law and arrange for investigation .
