With due respect and humble submission, in producing herewith one accused namely Rajiv Mallick(34) S/o Hari Charan Mallick of Cooliepara, W/No-01, near Saheb Hotel, Siliguri Junction PS Pradhan Nagar Dist Darjeeling under arrest along with following articles under proper seizure ;

- i) **18(Eighteen) Plastic bottles of Himalayan Gold, Country Spirit, 60\* up each bottle containing 600 ML.**

I ASI Ashit Singha of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today on 10.02.2022 in course Special drive duty at PS area with, I received an information that one person is storing and selling liquor illegally from his Hotel name styled as Saheb Hotel at Siliguri Junction under Pradhannagar PS for selling the same during ensuing Corporation election. Accordingly, I share the information to you and as per your kind instruction myself along with, CV/645 Pankaj Gupta, CV/223 Swapan Chhetri rush to the spot and as pointed by the source we held raid at the Hotel and apprehended the above noted person and recovered above noted articles, On demand he failed to produce any valid document in respect of recovered articles. On interrogation he admitted that he is selling the same illegally without obtaining valid document for his illegal gain during election time. Accordingly, I seized & label the above noted articles in between 09:15 hrs to 09:45 hrs and I arrested him.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Rajiv Mallick(34) S/o Hari Charan Mallick of Cooliepara, W/No-01, near Saheb Hotel, Siliguri Junction PS Pradhan Nagar Dist Darjeeling and arrange for its investigation.
