Dear Sir,

I, Sri Pijush Kanti Samaddar, son of Late Krishnadeal Samaddar, proprietor of M/s. Samaddar Enterprises, having received on office at 504, Nazrul Sarani, Ashrampara, Siliguri and 16:05 hrs. on 14/02/22 at residence of Jatin Das Sarani, Ashrampara, Siliguri, would like to bring your notice that I am senior citizen aged about 70 years. I am an electrical contractor of WBSEB CL and have been working with the department since 1975. Sometimes in the year 2017 I had received a work order from the department for installation of three nos of 11 KV feeders at designated worksite, i.e. from Jhankar 33/11 KV SS to (A) Airview More (B) Tumalpara & (C) Charchula by HTAB cable cable (RL = 7.755 KM) under Siliguri Town Division. I accepted the said order and initiated the work. Subsequently the concerned department advised not to initiate the work for Tumalpara feeder. As I was investigating the case, after completion of the work order, vide letter dated 22/09/2020 I intimated the concerned authority that as per their work order, the work for two feeders have been completed and as per their instruction I had not done the work order on the third feeder. Due to non-compliance of the third feeder some electrical materials allotted by WBSEB CL for the said work were lying in my custody which mainly included 11 KVA 95 Sq.mm cable, 10 nos of cable drums, along with PCC poles & other electrical materials. It is pertinent to mention hence that cables drums were not portable and storing the same in a shed.

P.T.O

area is not possible as such I approached our
Sri Sayantan Nandy, S/o - Timin Nandy for taking his
land situated at Rani Rashmikali Road, near Karunamoyee
Kalibari, Champaasaci Prachannahar, Siliguri on rent
for storing said Electrical cables. After taking the
land on rent I stored the heavy Electrical material
i.e. 10 nos cable drums including some assorted
materials. The rest of the portable Electric articles
I have stored it in a close space at my residence.
The said landed area is surrounded by walls
with two iron gates ^{with padlock}. Today when I went to the
said premise I found that small iron gate was
open and there was no padlock and also found that
lock with utter set shock and surprise that the
drums were broken and some portion of the cables
were cut and stolen from each drums even the
assorted materials lying with the cables were also
stolen. It is also relevant to mention here that
approximately a volume of ^(length) 4/5 drums were stolen
from the said premise.

I, therefore request you to investigate the matter
and book the culprits in accordance with law and
help me to recover the stolen articles.
