I, SMT. JAYA LAL CHAKRABORTY, wife of Tarun Chakraborty, D/o. Sri Bijay Lal, presently residing at R/o. Bhujiapanir chhat, near Amrit Dhara Water project, P.O. & P.S. Bagdogra, District Darjeeling, Pin-734014, West Bengal, India, would like to state that I was married to MR. TARUN CHAKRABORTY, S/o. Late Arun Chakraborty, R/o. C/o. Manik Sarkar, Bhuttabari, P.O. & P.S. Bagdogra, District Darjeeling, Pin-734014, West Bengal, on 21.11.2009 according to Hindu rites & customs at R/o. Bhujiapani, P.O. & P.S. Bagdogra, District Darjeeling, Pin-734014, West Bengal, India. After my marriage I inhabited with my husband and we have one (1) child namely Tanmoy Chakraborty aged about 11 years who at present is residing with me. At the time of marriage my husband assured me that he will keep me in good condition and will lead a happy married life. Everything was going good but the situation change. I was shocked when I saw his original face. After birth of my child my husband started demanding money. He started using slang language and insult me infront of everyone. My husband used to physically assault me unnecessarily everyday. My parents helped my husband monetarily. My husband always used to shout at me on simple issues and used to mentally & physically torture me to bring money from my old & aged parents. I tried my level best to give him everything in order to satisfy him but all went in vain. My parents even constructed a house at Bhujiapanir chhat, near Amrit Dhara Water project, Bagdogra where I and my husband used to reside.

'My parents are from middle class society it is impossible for my parents to fulfill his demands. His demands were never ending. Everyday he demanded money from my parents and forced me call my parents. On my denial my husband used to physically torture me. His regular mental and physical harassment has put my life in a miserable condition. Earlier also in several occasions I have been mentally and physically tortured by my husband but looking at my father's reputation I have adjusted and have never complaint before the Police Station. Lastly in the month of October, 2021 my husband physically assaulted me very badly and left the house. I and my husband work at Bagdogra Airport and whenever he see me outside Airport premises he physically assault me and uses slang language me. On 08-02-2022 my husband physically assaulted me at Bagdogra Airport in front of other workers. On 12-02-2022 my husband again threatened me outside Bagdogra Airport.

Finding no other way I came to you. I am in a deep trouble and therefore I request you to kindly take some necessary actions against my husband so that he stops harassing me physically and mentally.
